Amends GS 131E-136 as title indicates. Additionally expands the definition of home care services to include homemaker services provided in combination with in-home companion, sitter, respite, or other home care services. Specifies that the term *sitter* does not include child care facilities licensed under GS Chapter 110, and that the term *respite care* does not include mental health, developmental disabilities, or substance abuse facilities or services as licensed under GS Chapter 122C. Directs the NC Medical Care Commission to adopt rules to implement provisions regarding expanding the definition of home care services. The definition expansion provisions are effective July 1, 2008.
