S 1100. TOURISM PROMOTION GRANTS. Filed 3/20/07. *TO APPROPRIATE FUNDS TO THE DEPARTMENT OF COMMERCE FOR TOURISM PROMOTION GRANTS.*

Appropriates \$173,000 in each year of the biennium from the General Fund to the Department of Commerce to increase the current budget for tourism promotion grants. Sets out criteria for making the grants. Effective July 1, 2007.

S 1100. SHP FUNERAL EXPENSES (NEW). Filed 3/20/07. Senate committee substitute deletes the provisions of the 1st edition and replaces it with *AN ACT TO ALLOW THE DEPARTMENT OF CRIME CONTROL AND PUBLIC SAFETY TO EXPEND FUNDS TO COVER FUNERAL EXPENSES FOR MEMBERS OF THE STATE HIGHWAY PATROL KILLED IN THE LINE OF DUTY.* Amends GS 143B-476 to allow the Secretary of Crime Control and Public Safety to use up to \$10,000 of the Department's funds for the reimbursement of funeral expenses to the family of a State Highway Patrol member killed in the line of duty. Effective June 1, 2008.

S 1100. SHP FUNERAL EXPENSES. Filed 3/20/07. House amendment makes the following changes to 2nd edition.

Directs the Department of Crime Control and Public Safety (Department) to study whether the Secretary of Crime Control and Public Safety should be authorized to reimburse the family for funeral expenses of a state law enforcement officer who is killed in the line of duty. Directs the Department to report the study results and any recommendations for legislation to the Joint Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee by December 1, 2008. Effective when the act becomes law.

Adds sunset date of March 1, 2009, for proposed new subsection GS 143B-476(i).

S 1100. SHP FUNERAL EXPENSES. Filed 3/20/07. Conference report recommends the following changes to 2nd edition to reconcile matters in controversy. Changes the date by which the Department of Crime Control and Public Safety must report to the Joint Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee to January 1, 2009 (was set at December 1, 2008, by House amendment). Changes the expiration date of GS 143B-476(i) to June 1, 2009 (was set at March 1, 2009, by House amendment).

SL 2008-142 (S 1100). SHP FUNERAL EXPENSES. AN ACT TO ALLOW THE DEPARTMENT OF CRIME CONTROL AND PUBLIC SAFETY TO EXPEND FUNDS TO COVER FUNERAL EXPENSES FOR MEMBERS OF THE STATE HIGHWAY PATROL KILLED IN THE LINE OF DUTY, AND TO STUDY THE PAYMENT OF FUNERAL EXPENSES FOR STATE LAW ENFORCEMENT OFFICERS KILLED IN THE LINE OF DUTY. Summarized in *Daily Bulletin* 7/9/08, 7/17/08, and 7/18/08. Enacted July 28, 2008. Section 1 is effective June 1, 2008. The remainder is effective July 28, 2008.
