AMEND SUBSTANCE ABUSE PROFESSIONALS ACT (=H 2746).** Filed 5/27/08. *TO MAKE CERTAIN CLARIFYING CHANGES TO THE NORTH CAROLINA SUBSTANCE ABUSE PROFESSIONAL PRACTICE ACT, TO CLARIFY THE REQUIREMENTS OF MEMBERSHIP ON THE NORTH CAROLINA SUBSTANCE ABUSE PROFESSIONAL PRACTICE BOARD UNDER CERTAIN CIRCUMSTANCES, AND TO AMEND THE LAWS REQUIRING A PASSING SCORE ON AN ORAL EXAMINATION THEREBY AFFECTING FEES CHARGED BY THE BOARD UNDER THE LAWS REGULATING SUBSTANCE ABUSE PROFESSIONALS.*

**S 2117. AMEND SUBSTANCE ABUSE PROFESSIONALS ACT.** Filed 5/27/08. Senate committee substitute makes the following changes to 1st edition. Makes conforming and organizational changes to accommodate modifications made in the first edition so as to preserve alphabetical listing of definitions and maintain consistency of terminology within the provisions in the first edition. Makes conforming changes to GS 90-113.42(d).

**S 2117. AMEND SUBSTANCE ABUSE PROFESSIONALS ACT.** Filed 5/27/08. Senate committee substitute makes the following changes to 2nd edition. Deletes proposed GS 122C-142.1(b1)(6), which would have allowed a Provisional Licensed Clinical Addictions Specialist, registered by the North Carolina Substance Abuse Professional Practice Board, to conduct a substance abuse assessment. Deletes proposed GS 122C-142.1(d1)(4), which would have included a Provisional Licensed Clinical Addictions Specialist, as registered by the North Carolina Abuse Professional Practice Board, as one of the possible qualifications to be met by individuals who provide ADET school instruction as a department-authorized ADETS instructor.
