S 847. ENVIRONMENTAL TECHNICAL CORRECTIONS 2007. Filed 3/15/07. Senate committee substitute makes the following changes to 1st edition. Removes proposed amendments to GS 113-270.1A(a1). Makes technical changes in Section 2.

S 847. PREVENT AGRICULTURAL PESTICIDE EXPOSURE (NEW). Filed 3/15/07. House committee substitute deletes all provisions of 2nd edition and replaces it with *AN ACT TO ADD AGRICULTURAL WORKERS TO THOSE PROTECTED AGAINST RETALIATION IN THE WORKPLACE AND TO DIRECT THE PESTICIDE BOARD TO ADOPT RULES REQUIRING LICENSED PESTICIDE APPLICATORS TO RECORD THE SPECIFIC TIME OF DAY WHEN EACH PESTICIDE APPLICATION IS COMPLETED, AS RECOMMENDED BY THE GOVERNOR'S TASK FORCE ON PREVENTING AGRICULTURAL PESTICIDE EXPOSURE.* Amends GS 95-241(a) by adding workers regulated by the Pesticide Board (Article 52 of GS Chapter 143) to the list of employees protected from retaliatory employment discrimination under this statute.

Requires the Pesticide Board to adopt rules requiring (1) the recording of the specific time of day when each pesticide application was completed and (2) extending retention of records on pesticide applications for all pesticides covered under the Worker Protection Standards for Agricultural Pesticides from 30 days to two years.

SL 2008-212 (S 847). PREVENT AGRICULTURAL PESTICIDE EXPOSURE. AN ACT TO ADD AGRICULTURAL WORKERS TO THOSE PROTECTED AGAINST RETALIATION IN THE WORKPLACE AND TO DIRECT THE PESTICIDE BOARD TO ADOPT RULES REQUIRING LICENSED PESTICIDE APPLICATORS TO RECORD THE SPECIFIC TIME OF DAY WHEN EACH PESTICIDE APPLICATION IS COMPLETED, AS RECOMMENDED BY THE GOVERNOR'S TASK FORCE ON PREVENTING AGRICULTURAL PESTICIDE EXPOSURE.
