H 76. SCHOOL BOARD CANDIDATE FILING FEE. Filed 2/5/09. *TO SET A UNIFORM FILING FEE FOR BOARD OF EDUCATION CANDIDACY.*

Amends GS 163-294.2(e) (Notice of candidacy and filing fee in nonpartisan municipal elections), GS 163-291(3) (Partisan primaries and elections), and GS 163-107(a) (Filing fees required of candidates in primary; refunds) to provide for a \$100 filing fee for boards of education candidates. Effective for elections conducted on or after September 1, 2009.

H 76. SCHOOL BOARD CANDIDATE FILING FEE. Filed 2/5/09. House committee substitute makes the following changes to 1st edition.

Amends GS 163-294.2(e) (regarding nonpartisan municipal elections) and GS 163-291(3) (regarding partisan primaries and elections) to set a minimum filing fee for candidates for local boards of education elected on a nonpartisan or partisan basis. Sets the filing fee as 1% of the annual salary of the office sought, unless 1% of the annual salary for that office is less than \$25, in which case a minimum filing fee of \$25 is to be charged, (the filing fee was \$100 in the 1st edition). Amends GS 163-107(a) to clarify that the above filing fee formula applies to all candidates for boards of education, partisan or nonpartisan. Changes the effective date to January 1, 2010, (was, September 1, 2009) and provides that the act applies to elections held on or after that date.

H 76. SCHOOL BOARD CANDIDATE FILING FEE. Filed 2/5/09. House committee substitute changes the language used in the 2nd edition to make clear that \$25.00 is not the minimum filing fee for boards of education elected on a nonpartisan bases, but rather the fee is the greater of \$25 or 1% of the annual salary of the office sought.

H 76. HONOR WISHES OF MEMBERS OF MILITARY/REMAINS (NEW). Filed 2/5/09. Senate committee substitute deletes all provisions of the 3rd edition and replaces it with *AN ACT TO ALLOW A MEMBER OF THE MILITARY TO DESIGNATE THE TYPE, PLACE, AND METHOD OF DISPOSITION OF THE INDIVIDUAL'S REMAINS BY COMPLETING THE UNITED STATES DEPARTMENT OF DEFENSE RECORD OF EMERGENCY DATA, DD FORM 93, OR ITS SUCCESSOR FORM.*

Amends GS 130A-420(a) as the title indicates. Provides that a delegation made by filling out the United States Department of Defense Record of Emergency Data, DD Form 93 or its successor form is only effective if the individual dies under the circumstances described in 10 U.S.C. §1481(a)(1) through (8) and that this delegation takes precedence over any of the other methods set forth in the statute.

H 76. HONOR WISHES OF MEMBERS OF MILITARY REMAINS. Filed 2/5/09. Senate amendments make the following changes to 4th edition.

Amendment #1 amends GS 130A-420(a) to change the order of the methods by which an individual may authorize disposition of the individual's own body. Amends GS 90-210.124 to conform to changes made in the act to GS 130A-420. Makes clarifying and technical changes and amends the title to reflect conforming changes.

Amendment 2 enacts new GS 145-32 adopting the Honor and Remember Flag created by Honor and Remember, Inc., to honor veterans who died in the line of duty. Makes a conforming change to the title.

AN ACT TO ALLOW A MEMBER OF THE MILITARY TO DESIGNATE THE TYPE, PLACE, AND METHOD OF DISPOSITION OF THE INDIVIDUAL'S REMAINS BY COMPLETING THE UNITED STATES DEPARTMENT OF DEFENSE RECORD OF EMERGENCY DATA, DD FORM 93, OR ITS SUCCESSOR FORM, AND TO MAKE CONFORMING CHANGES AND TO ADOPT THE HONOR AND REMEMBER FLAG TO HONOR AND RECOGNIZE FALLEN MEMBERS OF THE ARMED FORCES.
