S 1165. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS (=H 1740). Filed 5/17/10. *TO MAKE TECHNICAL CORRECTIONS TO THE GENERAL STATUTES AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION.* Identical to H 1740, filed 5/17/10.

S 1165. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS. Filed 5/17/10. Senate committee substitute makes the following changes to 1st edition.

Makes technical corrections to GS 7A-809, GS 15-203, GS 15A-534(h), GS 15A-1230(b), GS 15A-1342(e), GS 15A-1383(d), GS 41-2(b), GS 58-71-75, GS 58-89A-106(a), GS 115C-102.6B(b), GS 115D-5.1(f1), GS 143C-8-6, GS 163-85(c), GS 163-182, and Section 1 of SL 2009-129.

Makes a conforming change to GS 20-183.7(f)(5) to require inspection stations to post that a vehicle that fails an inspection may be reinspected at the same station within 60 days (was, 30) of the inspection without payment of the fee.

Amends the catchline of GS 36C-3-302 to read: *Representation by holder of power of revocation or general power of appointment.*

Repeals GS 113-28 (obsolete provision reimbursing the federal government for certain work).

Amends GS 143B-499.8 (establishing the NC Silver Alert System) to include the terms *missing child* and *missing children* where necessary, to conform with legislative intent.

Also authorizes the Revisor of Statutes to recodify Part 3 in Article 36 of GS Chapter 143 in a more suitable location, to reflect duties transferred from the Department of Administration to the Department of Commerce.

S 1165. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS. Filed 5/17/10. House committee substitute makes the following changes to 2nd edition.

Makes technical corrections to GS 1-305(a), GS 1-361, GS 1-608(b), GS 1-611(d), GS 7A-498.7(b), GS 15A-1343(b1)(6), GS 15A-1343(b4)(1), GS 143B-262.4(b), GS 115C-296.4(d), GS 120-182(1), GS 135-45.8(13), GS 163-182, and GS 163-278.67(b).

Amends GS 1-242 (credits upon judgments) to require the clerk to render judgment, from which any party may appeal, in the same manner as in civil actions, in accordance with GS 1-301.1.

Amends GS 1-306 to provide that no execution upon any judgment which requires the payment of money (previously included the recovery of personal property also) may be issued at any time after 10 years from the date of the entry (was, rendition) thereof, with exception as indicated. Further adds that no execution upon any judgment which requires the recovery of personal property may be issued at any time after 10 years from the date of the judgment's entry. Makes additional technical changes.

Amends GS 7A-271(f) (superior court jurisdiction) and GS 7A-272(e) (district court jurisdiction) to also provide jurisdiction over *therapeutic court*. Makes conforming changes to GS 15A-1344(a1) (authority to supervise probation in drug treatment court).

Amends GS 58-76-5 (liability and right of action on official bonds) to remove the clerk of superior court from the list of parties against whom a person may institute suit for neglect, misconduct, or misbehavior in office. Makes additional technical changes.

Amends GS 110-129(9) (pertaining to child support) to remove the clerk of superior court from the definition of *initiating party*.

Amends GS 159D-53 to remove the Advisory Budget Commission from the list of state officers and government bodies which are to receive an annual report of its activities from the NC Capital Facilities Finance Agency.

Amends Section 47.4 of SL 2009-574 to require the Commission to Study the Governance and the Adequacy of the Investment Authority of Various State-Owned Funds for the Purposes of

Enhancing the Return on Investments to make its final report to the 2011 (was, 2010) Regular Session of the 2011 General Assembly.

Makes a technical change to the lead-in language of Section 3 of House Bill 76, 2009 Regular Session, if that bill becomes law.

Makes a technical change to GS 108A-70.29(b)(2)b in House Bill 382, 2009 Regular Session, if that bill becomes law. Effective July 1, 2010, and applies to reviews of Health Choice Program on or after that date, as indicated.

If House Bill 1729, 2009 Regular Session becomes law, then amends GS 20-63(g), as amended, to clarify that any operator of a motor vehicle who covers any registration plate with any frame or transparent, clear, or color-tinted cover that makes a number or letter included in the vehicle's registration (was, on the plate), the state name, or a number or month on the sticker on the plate illegible commits an infraction and shall be penalized. Effective December 1, 2010, and applies to offenses committed on or after that date.

Makes a technical change to Senate Bill 1177, 2009 Regular Session, if that bill becomes law.

S 1165. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS. Filed 5/17/10. House amendment makes the following changes to 3rd edition.

Provides that if House Bill 1973 (various economic incentives), 2009 Regular Session, becomes law, the read-in language for Section 3.4 of that bill is amended by deleting the citation *GS 150-129.52* and replacing it with *GS 105-129.52*.

Provides that if House Bill 2066 (special retirement allowances), 2009 Regular Session, becomes law, Section 6.1 is amended to provide the following: (1) Effective January 1, 2011, Section 9(a) and 9(b) of SL 2010-72 are repealed; (2) Effective July 1, 2010, Section 10(a) and 10(b) of SL 2010-72 are repealed; and (3) this Section is effective when it becomes law.

Provides that if Senate Bill 1242 (clarifying changes to General Statutes), 2009 Regular Session, becomes law, GS 143-340(1) is amended to establish the State Employee Suggestion (was, Incentive Bonus) Program.

Amends the whereas clause of Senate Resolution 1177, 2005 Regular Session, to correct R.C. Soles, Jr.'s information as to consecutive terms served in the North Carolina General Assembly. Provides that he served 21 consecutive terms, serving four terms in the House of Representatives and 17 terms in the Senate.
