S 346. KANNAPOLIS DEANNEXATION. Filed 2/26/09. *TO REMOVE A DESCRIBED AREA FROM THE CORPORATE LIMITS OF THE CITY OF KANNAPOLIS.*

S 346. KANNAPOLIS DEANNEXATION/EXPEDITE SCHOOLS (NEW). Filed 2/26/09. Senate committee substitute makes the following changes to 1st edition. Allows the Cabarrus County Board of Commissioners and the Cabarrus County Board of Education to jointly select and negotiate with a contractor to build school facilities using the repetitive design approach without being subject to the following: GS 143-128, GS 143-129, GS 143-131, GS 143-132, GS 143-64.31, and GS 143-64.32. Requires the boards to jointly determine that using the selection and negotiations processes instead of competitive bidding will expedite the project, create an effective construction team; and control costs, quality, and schedule. Makes a conforming change to the title. Expires June 30, 2014.

S 346. KANNAPOLIS DEANNEXATION/EXPEDITE SCHOOLS. Filed 2/26/09. House committee substitute makes the following changes to 2nd edition. Amends Section 3 of SL 1989-102 to establish the filing period for the election of members of the Cabarrus County Board of Education as beginning at noon on the second Monday in February and expiring at noon on the last business day in February (was, beginning at noon on the first Friday in July next preceding the general election in even-numbered years and expiring at noon on the first Friday in August) next preceding the general election in even-numbered years.

Makes conforming changes to the title.

August 4, 2009

S 346. KANNAPOLIS DEANNEXATION/EXPEDITE SCHOOLS. Filed 2/26/09. House amendments make the following changes to 3rd edition. Amendment #1 amends SL 1989-102, Section 3, to provide that the filing period for the election of a member of the Cabarrus County Board of Education shall be the same as for county officers under GS 163-106. Amendment #2 specifies that minority participation goals requirements in specified statutes are not waived.

August 5, 2009

S 346. KANNAPOLIS DEANNEXATION/EXPEDITE SCHOOLS. Filed 2/26/09. House amendment makes the following changes to 4th edition. Adds requirement to authorization for school construction that appropriate certification of the amount owed be obtained before funds are disbursed by the county or the Board of Education. Further states that no disbursements may be made if the county or Board of Education receives notice of a subcontractor's claim unless and until the contractor provides satisfactory proof that the claim has been resolved.

SL 2009-430 (S 346). KANNAPOLIS DEANNEXATION/EXPEDITE SCHOOLS. AN ACT TO REMOVE A DESCRIBED AREA FROM THE CORPORATE LIMITS OF THE CITY OF KANNAPOLIS, TO ASSIST CABARRUS COUNTY WITH THE EXPEDITING OF PUBLIC SCHOOL CONSTRUCTION, AND TO MODIFY THE FILING PERIOD FOR THE ELECTION OF MEMBERS TO THE CABARRUS COUNTY BOARD OF EDUCATION.
