S 886. IMPROVE SUCCESS OF FMPS. Filed 3/25/09. *TO PROVIDE THAT FISHERY MANAGEMENT PLANS MUST MEET A STANDARD OF AT LEAST FIFTY PERCENT PROBABILITY OF ACHIEVING THE TARGET MORTALITY RATE FOR THE FISHERY OR FISHERIES.*

Amends GS 113-182.1(b) as title indicates.

S 886. IMPROVE SUCCESS OF FMPS. Filed 3/25/09. Senate committee substitute makes the following changes to 1st edition. Changes the title to *AN ACT TO PROVIDE THAT EACH FISHERY MANAGEMENT PLAN MUST INCLUDE A STANDARD TO ENSURE THAT THE PLAN ACHIEVES THE TARGET MORTALITY RATE FOR THE FISHERY OR FISHERIES.*

Amends GS 113-182.1(b)(5) to require each Fishery Management Plan to include a standard to ensure that the plan achieves the target mortality rate for the fishery or fisheries (rather than requiring each plan to meet a standard of at least 50% probability of achieving the target mortality rate, as provided in the 1st edition).

S 886. CLEANFIELDS ACT OF 2010. Filed 3/25/09. House committee substitute makes the following changes to 2nd edition. Deletes prior edition and replaces with new *ACT TO AUTHORIZE THE ESTABLISHMENT OF CLEANFIELDS RENEWABLE ENERGY DEMONSTRATION PARKS IN THE STATE.* Authorizes state designation of a former manufacturing site as a “cleanfields renewable energy demonstration park” setting the criteria for designation including a site of at least 250 acres, possible remediation under CERCLA, and at least three renewable energy or alternative fuel facilities.

July 7, 2010

S 886. CLEANFIELDS ACT OF 2010. Filed 3/25/09. House committee substitute makes the following changes to 3rd edition.

Expands the criteria for designation as a cleanfields renewable energy demonstration park to require that (1) the development plan for the park include a biomass renewable energy facility that utilizes refuse derived fuel as the primary source for generating energy and (2) the owners of the park certify that the initial biomass renewable energy facility will not be a major source, as the term is defined in 40 C.F.R. § 70.2 (July 1, 2009 edition), for air quality purposes.

Permits the Secretary of State to rely on certifications provided by the owner or the Department of Environment and Natural Resources that the criteria for designation as a cleanfields renewable energy demonstration park have been met.

Assigns priority to the use of any electric power or renewable energy certificates generated from renewable energy resources at the biomass renewable energy facility to meet the requirements of GS 62-133.8(f) (Compliance with Renewable Energy and Energy Efficiency Portfolio Standard (REPS) Requirement through Use of Poultry Waste Resources). Provides that only when the requirements of GS 62-133.8(f) have been met are any remaining credits to be used to comply with GS 62-133.8(b) (REPS for Electric Public Utilities) and GS 62-133.8(c) (REPS for Electric Membership Corporations and Municipalities). Provides that the triple credit assigned to any electric power or renewable energy facility meeting specified guidelines is to apply only to the first 20 megawatts of biomass renewable energy facility generation capacity located in all cleanfields renewable energy demonstration parks in the state.

July 8, 2010

S 886. CLEANFIELDS ACT OF 2010. Filed 3/25/09. House amendment makes the following changes to 4th edition.

Clarifies one of the 10 criteria required to designate land as a cleanfields renewable energy demonstration park as follows: (1) the initial biomass renewable energy facility will not be a major

source, as that term is defined in 40 C.F.R. § 70.2 (July 1, 2009, edition), for air quality purposes (previous version required the owners of the park to certify as such); (2) the biomass renewable energy facility will remain in compliance with all applicable state and federal emissions requirements throughout its operating life.

Also makes clarifying changes to the section detailing the priority for use of additional (was, remaining) credits from electric power or renewable energy certificates generated from renewable energy resources, as specified.
