moves to amend the bill on page-1, lines 5-6, by deleting the phrase "TO PROVIDE TIER ONE TREATMENT FOR PORT ENHANCEMENT ZONES;";

and on page 2, lines 35 through 42, by rewriting the lines to read:

Definition. – For the purposes of this section, a 'large manufacturing and distribution facility' is a facility that is to be used primarily for manufacturing or assembling products and distributing finished products for which the Secretary of Commerce makes a certification that an investment of private funds of at least eighty million dollars (\$80,000,000) has been or will be made in real and tangible personal property for the facility within five years after the date on which the first property investment is made and that the facility will achieve an employment level of at least 550 within five years after the date the facility is placed into service and maintain that minimum level of employment throughout its operation.";

and on page 3, lines 21 through 29, by rewriting the lines to read:

Large manufacturing and distribution facility. – A facility that is to be used "(2)primarily for manufacturing or assembling products and distributing finished products for which the Secretary of Commerce makes a certification that an investment of private funds of at least eighty million dollars (\$80,000,000) has been or will be made in real and tangible personal property for the facility within five years after the date on which the first property investment is made and that the facility will achieve an employment level of at least 550 within five years after the date the facility is placed into service and maintain that minimum level of employment throughout its operation.";

and on page 4, line 2, through page 7, line 27, by deleting those lines;

and on page 7, lines 40-42, by rewriting those lines to read:

"to which the credit is claimed is less than 200,200 and (ii) the taxpayer has failed to maintain at least 125 employees at the property and, within two years of the date the employment fell below 200, to invest at the property the greater of five million dollars (\$5,000,000) or at least twice the value of the remaining installments of the credit, the credit expires and the taxpayer may not".
