Representative Brubaker

1 moves to amend the bill on Page 10, Line 37, by inserting immediately after that line a new
2 section to read:

3 **"PART VI-A. CAPITAL APPROPRIATIONS**

5 **SECTION 6A.1.(a)** If House Bill 950, 2012 Regular Session of the General
6 Assembly, becomes law, then Section 26.1 of that act is amended by adding a new subsection
7 to read:

8 **"SECTION 26.1.(b)** The General Assembly authorizes the Department of Public
9 Safety to complete the Greensboro Readiness Center Renovation and Expansion capital
10 improvement project and authorizes funding for the project in accordance with this subsection.
11 The Department of Public Safety may use up to one million three hundred seventy-three
12 thousand three hundred thirty dollars (\$1,373,330) of funds available that are authorized by
13 Section 18.2 of S.L. 2011-145 to be used as State matching funds for this project. The
14 remainder of the project costs shall be paid from federal matching funds. The total project cost
15 shall not exceed the sum of five million four hundred eight-nine thousand eight hundred twenty
16 dollars (\$5,489,820)."

17 **SECTION 6A.1.(b)** If House Bill 950, 2012 Regular Session of the General
18 Assembly, becomes law, then Section 18.2 of S.L. 2011-145 reads as rewritten:

19 **"FEDERAL GRANT MATCHING FUNDS**

20 **SECTION 18.2.** Notwithstanding the provisions of G.S. 143C-6-9, the Department
21 of Correction may use up to the sum of one million two hundred thousand dollars (\$1,200,000)
22 during the 2011-2012 fiscal year and up to the sum of ~~one million two hundred thousand~~
23 ~~dollars (\$1,200,000)~~ two million five hundred seventy-three thousand three hundred thirty
24 dollars (\$2,573,330) during the 2012-2013 fiscal year from funds available to the Department
25 to provide the State match needed in order to receive federal grant funds. Prior to using funds
26 for this purpose, the Department shall report to the Chairs of the House of Representatives and
27 Senate Appropriations Subcommittees on Justice and Public Safety and the Joint Legislative
28 Commission on Governmental Operations on the grants to be matched using these funds."


