16 approved by the Commissioner. The following information shall be included about a reportable
17 crash:

- 18 (1) The cause of the crash.
- 19 (2) The conditions existing at the time of the crash.
- 20 (3) The persons and vehicles ~~involved.~~ involved, except that the name and
21 address of a minor child involved in a school bus crash who is a passenger
22 on a school bus may only be disclosed to (i) the local board of education, (ii)
23 The State Board of Education, (iii) the parent or guardian of the child, (iv) an
24 insurance company investigating a claim arising out of the crash, (v) an
25 attorney representing a person involved in the crash, and (vi) law
26 enforcement officials investigating the crash. As used in this subdivision,
27 "school bus" also includes a school activity bus as defined by G.S. 20-
28 4.01(27).
- 29 (4) Whether the vehicle has been seized and is subject to forfeiture under G.S.
30 20-28.2.";
