3 "G.S. 15A-145.5; AND TO REQUIRE AN EMPLOYER, EDUCATIONAL
4 INSTITUTION, OR STATE OR LOCAL GOVERNMENT AGENCY TO ADVISE AN
5 APPLICANT THAT THE APPLICANT IS NOT REQUIRED TO DISCLOSE
6 INFORMATION REGARDING AN ARREST, CRIMINAL CHARGE, OR CRIMINAL
7 CONVICTION OF THE APPLICANT THAT HAS BEEN EXPUNGED PRIOR TO
8 REQUESTING DISCLOSURE.";

10 and on page 2, lines 14-18, by deleting those lines and substituting the following language to
11 read:

12 "(c) Employer or Educational Institution Inquiry Regarding Disclosure of Expunged
13 Arrest, Criminal Charge, or Conviction. – An employer or educational institution who requests
14 disclosure of information concerning any arrest, criminal charge, or criminal conviction of the
15 applicant shall first advise the applicant that State law allows the applicant to not refer to any
16 arrest, charge, or conviction that has been expunged. An applicant need not, in answer to any";

18 and on page 2, lines 23-28, by deleting those lines and substituting the following language to
19 read:

20 "(d) State or Local Government Agency, Official, and Employee Inquiry Regarding
21 Disclosure of Expunged Arrest, Criminal Charge, or Conviction. – Agencies, officials, and
22 employees of the State and local governments who request disclosure of information
23 concerning any arrest, criminal charge, or criminal conviction of the applicant shall first advise
24 the applicant that State law allows the applicant to not refer to any arrest, charge, or conviction
25 that has been expunged. An applicant need not, in answer to any question".
