**SECTION 7.(a)** G.S. 160A-272 reads as rewritten:

"§ 160A-272. Lease or rental of property.

The council may approve a lease for the siting and operation of a renewable energy facility, as that term is defined in G.S. 62-133.8(a)(7), for a term up to 20-25 years without treating the lease as a sale of property and without giving notice by publication of the intended lease. This subsection applies to Catawba, Mecklenburg, and Wake Counties, the Cities of Asheville, Raleigh, and Winston-Salem, and the Towns of Apex, Carrboro, Cary, Chapel Hill, Fuguay-Varina, Garner, Holly Springs, Knightdale, Morrisville, Rolesville, Wake Forest, Wendell, and Zebulon only."

**SECTION 7.(b)** Section 3 of S.L. 2010-57 reads as rewritten:

"SECTION 3. This act is effective when it becomes law and but Section 1 expires June 30, 2015.".
