- 1 moves to amend the bill on page 1, line 23,
- 2 by deleting "AND" on that line; and
- 3
- 4 on page 1, line 27,
- 5 by changing the period on that line to a semi-colon and adding the following:
- 6 "AND TO INCREASE THE PENALTY FOR CARRYING A CONCEALED HANDGUN
- 7 WHILE CONSUMING ALCOHOL.";
- 8
- 9 And on page 8, lines 8-10,
- 10 By rewriting those lines to read:
- 11 "SECTION 13. G.S. 14-415.21 reads as rewritten:
- 12 '**§ 14-415.21. Violations of this Article punishable as an infraction.**
- 13 (a) A person who has been issued a valid permit who is found to be carrying a
- 14 concealed handgun without the permit in the person's possession or who fails to disclose to any
- 15 law enforcement officer that the person holds a valid permit and is carrying a concealed
- 16 handgun, as required by G.S. 14-415.11, shall be guilty of an infraction and shall be punished
- 17 in accordance with G.S. 14-3.1. In lieu of paying a fine the person may surrender the permit.
- 18 (a1) Any person who is found to be carrying a concealed handgun in violation of G.S.
- 19 14-415.11(c2) is guilty of a Class A1 misdemeanor and shall pay a minimum fine of one
- 20 thousand dollars (\$1,000). In addition to the criminal penalty imposed under this subsection,
- 21 the sheriff shall also revoke the permit of any person convicted under this subsection pursuant
- 22 to G.S. 14-415.18 for a period of five years.
- 23 (b) A person who violates the provisions of this Article other than as set forth in subsection
- 24 (a) or (a1) of this section is guilty of a Class 2 misdemeanor.'
- 25 SECTION 14. Sections 1 through 6 of this act and Section 13 of this act become
- 26 effective October 1, 2013, and apply to offenses committed on or after that date. The
- 27 remainder of this act becomes effective October 1, 2013. "
