

19		<u>(2)</u>	Make the construction plans, specifications, and requirements available for
20			review by prospective local businesses or provide those documents to them
21			at least 30 days before the bid or proposals are due.
22		<u>(3)</u>	Negotiate in good faith with interested local businesses and do not reject
23			them as unqualified without sound reasons based on their capabilities.
24	<u>(b)</u>		bidder shall identify on its bid the local businesses that it will use on the
