2	AN ACT REQUIRING UTILITY OWNERS TO LOCATE AND DESCRIBE				
3	UNDERGROUND UTILITIES UPON WRITTEN OR ORAL REQUEST FROM A				
4	PERSON WHO IS RESPONSIBLE FOR DESIGNING OR SURVEYING				
5	UNDERGROUND FACILITIES OR REQUIRES A GENERAL DESCRIPTION AND				
6	LOCATION OF EXISTING UNDERGROUND FACILITIES IN AN AREA.				
7	The General Assembly of North Carolina enacts:				
8	<b>SECTION 1.</b> G.S. 87-101 reads as rewritten:				
9	"§ 87-101. Definitions.				
10	As used in this Article:				
11	(1) "Association" means an association, sponsored by utility owners, that will				
12	provideprovides for receipt of notification of excavation operations and				
13	surveyor or designer operations in a defined geographical area, and that will				
14	maintainmaintains the records of the notifications.				
15					
16	(10a) "Small water or wastewater utility owner" means any person who owns or				
17	operates any underground line, system, or facility that is used for producing,				
18	storing, conveying, transmitting, or distributing water under pressure or				
19	sanitary sewage and that serves 100 or fewer service connections.				
20					
21	(11a) "Surveyor or designer" means a person who is responsible for designing or				
22	surveying underground utilities or requires a general description and location				
23	of existing underground utilities in an area.

25	<b>SECTION 2.</b> Article 8 of Chapter 87 of the General Statutes is amended by adding				
26	a new section to read as follows:				
27	" <u>§ 87-107.1. Surveyor or designer requests; notice required; duties of utility owners.</u>				
28	(a) Before surveying an area containing highways, public spaces, or private easements				
29	of a utility owner, a surveyor or designer may give notice to each utility owner having				
30	underground utilities located in the area to be surveyed, or to the utility owner's designated				
31	representative or association, either orally or in writing, not less than two nor more than 10				
32	working days prior to starting, of the surveyor's or designer's intent to have a survey conducted.				
33	The written or oral notice shall contain all of the following:				
34	(1) The name, address, and telephone number of the surveyor or designer.

9	(c) Each	utility owner or designated representative or association, other than a small			
10	water or wastew	vater utility owner, notified of an intent to survey under subsection (a) of this			
11	section shall, before the proposed start of the survey, unless another period is agreed to by the				
12	surveyor or desi	gner and the utility owner or designated representative or association, provide			
13	the following in	formation to the surveyor or designer to the extent the information is reflected			
14	by records in the	possession of and reasonably available to the utility owner:			
15	<u>(1)</u>	The location and description of all of the underground utilities within the			
16		area to be surveyed.			
17	<u>(2)</u>	The location and description of all utility markers indicating the location of			
18		the underground utilities within the area to be surveyed.			
19	<u>(3)</u>	Temporary markings with paint, flags, or other visible means on the surface			
20		of the ground indicating the location of the underground utilities in locations			
21		where permanent utility markers do not exist.			
22	<u>(4)</u>	Any other information that would assist in locating the underground			
23		<u>utilities.</u> "			
24	SEC	<b>TION 3.</b> This act becomes effective July 1, 2013, and applies to notices given			
25	on or after that d	late.
