1	A BILL TO BE ENTITLED
2	AN ACT TO DISTRICT THE STANLY COUNTY BOARD OF COMMISSIONERS AND
3	THE STANLY COUNTY BOARD OF EDUCATION.
4	The General Assembly of North Carolina enacts:
5	SECTION 1.(a) Notwithstanding any other provision of law, the Board of County
6	Commissioners of Stanly County shall consist of seven members to be elected as follows:
7	(1) Four members shall be elected from single-member districts, with the
8	qualified voters of each district electing the member from that district, who
9	shall serve two-year terms.
10	(2) Three members shall be elected at large, who shall serve four-year terms.
11	SECTION 1.(b) Each candidate for a district seat must reside in the district for
12	which the election is sought.
13	SECTION 2.(a) In 2014 and biennially thereafter, under the districts set out in or
14	as modified in accordance with this act, there shall be elected to serve on the Board of County
15	Commissioners of Stanly County one member each from District 1, District 2, District 3, and
16	District 4. In 2014 and quadrennially thereafter, one member shall be elected at large to serve a
17	four-year term. In 2016 and quadrennially thereafter, two members shall be elected at large to
18	serve a four-year term. All of the elections shall be held at the time of the general election.
19	SECTION 2.(b) Nothing in this section shall alter or change the term of office of
20 21	any member of the Stanly County Board of Commissioners that expires in 2016.
21	SECTION 2.(c) This section becomes effective July 1, 2014. SECTION 3.(a) Notwithstanding the Plan for the Merger of the Stanly County and
22	Albemarle City Schools or any other provision of law, the Board of Education of Stanly County
23 24	shall consist of seven members to be elected as follows:
25	(1) Four members shall be elected from single-member districts, with the
26	qualified voters of each district electing the member from that district, who
27	shall serve two-year terms.
28	(2) Three members shall be elected at large who shall serve four-year terms.
29	SECTION 3.(b) Each candidate for a district seat must reside in the district for
30	which the election is sought.
31	SECTION 3.(c) In 2014, of the four seats with expiring terms of office, only two
32	shall be elected to serve a four-year term of office in at-large seats. Nothing in this section shall
33	alter or change the term of office of any member of the Stanly County Board of Education that
34	expires in 2016.
35	SECTION 3.(d) In 2016 and biennially thereafter, under the districts set out in or
36	as modified in accordance with this act, there shall be elected to serve on the Board of

Education of Stanly County one member each from District 1, District 2, District 3, and District 1 2 4. In 2016 and quadrennially thereafter, one member shall be elected at large to serve a 3 four-year term. In 2018 and quadrennially thereafter, two members shall be elected at large to 4 serve a four-year term. 12	remain identical. G.S. 153A-22 applies to the Stanly County Board of Commissioners.	
13	SECTION 6. This act applies to Stanly County only.	
14	SECTION 7. This act is effective when it becomes law.
