5	"BASTARDY", TO ALLOW A CHILD BORN OUT OF WEDLOCK TO INHERIT	
6	FROM A PERSON WHO DIED PRIOR TO OR WITHIN ONE YEAR AFTER THE	
7	BIRTH OF THAT CHILD IF PATERNITY CAN BE ESTABLISHED BY DNA	
8	TESTING, AND TO MAKE OTHER TECHNICAL CORRECTIONS TO THE	
9	STATUTES BEING AMENDED.

1 If the child resides with the surviving spouse of the deceased parent at the time the 2 allowance is paid, the allowance shall be paid to the surviving spouse for the benefit of the 3 child. G.S. 49-7 reads as rewritten: 28 "§ 49-7. Issues and orders. 29 The court before which the matter may be brought shall determine whether or not the

30 defendant is a parent of the child on whose behalf the proceeding is instituted. After this matter has been determined in the affirmative, the court shall proceed to determine the issue as to 31 32 whether or not the defendant has neglected or refused to provide adequate support and maintain 33 the child who is the subject of the proceeding. After this matter shall have been has been 34 determined in the affirmative, the court shall fix by order, subject to modification or increase 35 from time to time, a specific sum of money necessary for the support and maintenance of the 36 child, subject to the limitations of G.S. 50-13.10. The amount of child support shall be 37 determined as provided in G.S. 50-13.4(c). The order fixing the sum shall require the defendant 38 to pay it either as a lump sum or in periodic payments as the circumstances of the case may 39 appear to the court. The social security number, if known, of the minor child's parents shall be 40 placed in the record of the proceeding. Compliance by the defendant with any or all of the 41 further provisions of this Article or the order or orders of the court requiring additional acts to 42 be performed by the defendant shall not be construed to relieve the defendant of his or her 43 responsibility to pay the sum fixed or any modification or increase thereof.

44 The court before whom the matter may be brought, on motion of the State or the defendant, 45 shall order that the alleged-parent defendant, the known natural parent, and the child submit to 46 any blood tests and comparisons which have been developed and adapted for purposes of 47 establishing or disproving parentage and which are reasonably accessible to the alleged-parent 48 defendant, the known natural parent, and the child. The results of those blood tests and 49 comparisons, including the statistical likelihood of the alleged parent's parentage, if available, 50 shall be admitted in evidence when offered by a duly qualified, licensed practicing physician, 51 duly qualified immunologist, duly qualified geneticist or other duly qualified person. In addition, if a jury tries 3 the issue of parentage, they shall be instructed as set out in G.S. 8-50.1. From a finding on the 4 issue of parentage against the alleged-parent defendant, the alleged-parent defendant has the 5 same right of appeal as though he or she had been found guilty of the crime of willful failure to 6 support an illegitimate child.a child born out of wedlock." 7 SECTION 21. Definitions. 30 When used in this Article, unless the context otherwise requires: 31 . . . 32 (2)Employee. - The term "employee" means every person engaged in an 33 employment under any appointment or contract of hire or apprenticeship, 34 express or implied, oral or written, including aliens, and also minors, 35 whether lawfully or unlawfully employed, but excluding persons whose 36 employment is both casual and not in the course of the trade, business, 37 profession, or occupation of his employer, and as relating to those so 38 employed by the State, the term "employee" shall include all officers and 39 employees of the State, including such as are elected by the people, or by the 40 General Assembly, or appointed by the Governor to serve on a per diem, 41 part-time or fee basis, either with or without the confirmation of the Senate; 42 as relating to municipal corporations and political subdivisions of the State, 43 the term "employee" shall include all officers and employees thereof, 44 including such as are elected by the people. The term "employee" shall 45 include members of the North Carolina National Guard while on State active duty under orders of the Governor and members of the North Carolina State 46 47 Defense Militia while on State active duty under orders of the Governor. The 48 term "employee" shall include deputy sheriffs and all persons acting in the 49 capacity of deputy sheriffs, whether appointed by the sheriff or by the 50 governing body of the county and whether serving on a fee basis or on a 51 salary basis, or whether deputy sheriffs serving upon a full-time basis or a

part-time basis, and including deputy sheriffs appointed to serve in an emergency, but as to those so appointed, only during the continuation of the emergency. The sheriff shall furnish to the board of county commissioners a complete list of all deputy sheriffs named or appointed by him immediately after their appointment and notify the board of commissioners of any changes made therein promptly after such changes are made. Any reference to an employee who has been injured shall, when the employee is dead, include also his legal representative, dependents, and other persons to whom compensation may be payable: Provided, further, that any employee, as herein defined, of a municipality, county, or of the State of North Carolina, while engaged in the discharge of his official duty outside the jurisdictional or territorial limits of the municipality, county, or the State of North Carolina and while acting pursuant to authorization or instruction from any superior officer, shall have the same rights under this Article as if such duty or activity were performed within the territorial boundary limits of his employer. Every executive officer elected or appointed and empowered in

Every executive officer elected or appointed and empowered in accordance with the charter and bylaws of a corporation shall be considered as an employee of such corporation under this Article.

Any such executive officer of a corporation may, notwithstanding any other provision of this Article, be exempt from the coverage of the corporation's insurance contract by such corporation's specifically excluding such executive officer in such contract of insurance, and the exclusion to remove such executive officer from the coverage shall continue for the period such contract of insurance is in effect, and during such period such executive officers thus exempted from the coverage of the insurance contract shall not be employees of such corporation under this Article.

All county agricultural extension service employees who do not receive official federal appointments as employees of the United States Department of Agriculture and who are field faculty members with professional rank as designated in the memorandum of understanding between the North Carolina Agricultural Extension Service, North Carolina State University, A & T State University, and the boards of county commissioners shall be deemed to be employees of the State of North Carolina. All other county agricultural extension service employees paid from State or county funds shall be deemed to be employees of the county board of commissioners in the county in which the employee is employed for purposes of workers' compensation.

The term "employee" shall also include members of the Civil Air Patrol currently certified pursuant to G.S. 143B-491(a) [G.S. 143B-1031(a)]G.S. 143B-1031(a) when performing duties in the course and scope of a State-approved mission pursuant to Article 11 of Chapter 143B [Subpart C of Part 5 of Article 13 of Chapter 143B] Subpart C of Part 5 of Article 13 of Chapter 143B of the General Statutes.

"Employee" shall not include any person performing voluntary service as a ski patrolman who receives no compensation for such services other than meals or lodging or the use of ski tow or ski lift facilities or any combination thereof.

49Any sole proprietor or partner of a business or any member of a limited50liability company may elect to be included as an employee under the51workers' compensation coverage of such business if he is actively engaged in

1		the operation of the business and if the insurer is notified of his election to
2		be so included. Any such sole proprietor or partner or member of a limited
3		liability company shall, upon such election, be entitled to employee benefits
4		and be subject to employee responsibilities prescribed in this Article.
5		"Employee" shall include an authorized pickup firefighter of the Division
6		of Forest Resources of the Department of Agriculture and Consumer
7		Services when that individual is engaged in emergency fire suppression
8		activities for the Division of Forest Resources. As used in this section,
9		"authorized pickup firefighter" means an individual who has completed
10		required fire suppression training as a wildland firefighter and who is
11		available as needed by the Division of Forest Resources for emergency fire
12		suppression activities, including immediate dispatch to wildfires and standby
13		for initial attack on fires during periods of high fire danger.
14		It shall be a rebuttable presumption that the term "employee" shall not
15		include any person performing services in the sale of newspapers or
16		magazines to ultimate consumers under an arrangement whereby the
17		newspapers or magazines are to be sold by that person at a fixed price and
18		the person's compensation is based on the retention of the excess of the fixed
19 20		price over the amount at which the newspapers or magazines are charged to
20 21		the person.
21 22	(5)	Average Weekly Wages. – "Average weekly wages" shall mean the earnings
22	(5)	of the injured employee in the employment in which he was working at the
23 24		time of the injury during the period of 52 weeks immediately preceding the
24 25		date of the injury, including the subsistence allowance paid to veteran
23 26		trainees by the United States government, provided the amount of said
20 27		allowance shall be reported monthly by said trainee to his employer, divided
28		by 52; but if the injured employee lost more than seven consecutive calendar
29		days at one or more times during such period, although not in the same
30		week, then the earnings for the remainder of such 52 weeks shall be divided
31		by the number of weeks remaining after the time so lost has been deducted.
32		Where the employment prior to the injury extended over a period of fewer
33		than 52 weeks, the method of dividing the earnings during that period by the
34		number of weeks and parts thereof during which the employee earned wages
35		shall be followed; provided, results fair and just to both parties will be
36		thereby obtained. Where, by reason of a shortness of time during which the

48 49 Where a minor employee, under the age of 18 years, sustains a permanent disability or dies leaving dependents surviving, the compensation payable for permanent disability or death shall be calculated, first, upon the average weekly wage paid to adult employees employed by the same employer at the time of the accident in a similar or like class of work which the injured minor employee would probably have been promoted to if not injured, or, second, upon a wage sufficient to yield the maximum weekly compensation benefit. Compensation for temporary total disability or for the death of a minor without dependents shall be computed upon the average weekly wage at the time of the accident, unless the total disability extends more than 52 weeks, and then the compensation may be increased in proportion to his expected earnings.

In case of disabling injury or death to a volunteer fireman; member of an organized rescue squad; an authorized pickup firefighter, as defined in subdivision (2) of this section, when that individual is engaged in emergency fire suppression activities for the Division of Forest Resources; a duly appointed and sworn member of an auxiliary police department organized pursuant to G.S. 160A-282; or senior members of the State Civil Air Patrol functioning under Article 11 of Chapter 143B [Subpart C of Part 5 of Article 13 of Chapter 143B] Subpart C of Part 5 of Article 13 of Chapter 143B of the General Statutes, under compensable circumstances, compensation payable shall be calculated upon the average weekly wage the volunteer fireman, member of an organized rescue squad, authorized pickup firefighter of the Division of Forest Resources, when that individual is engaged in emergency fire suppression activities for the Division of Forest Resources, member of an auxiliary police department, or senior member of the State Civil Air Patrol was earning in the employment wherein he principally earned his livelihood as of the date of injury. Provided, however, that the minimum compensation payable to a volunteer fireman, member of an organized rescue squad, an authorized pickup firefighter of the Division of Forest Resources of the Department of Agriculture and Consumer Services, when that individual is engaged in emergency fire suppression activities for the Division of Forest Resources, a sworn member of an auxiliary police department organized pursuant to G.S. 160A-282, or senior members of the State Civil Air Patrol shall be sixty-six and two-thirds percent (66 2/3%) of the maximum weekly benefit established in G.S. 97-29.

- (12) Child, Grandchild, Brother, Sister. The term "child" shall include a posthumous child, a child legally adopted prior to the injury of the employee, and a stepchild or acknowledged illegitimate child born out of wedlock dependent upon the deceased, but does not include married children unless wholly dependent upon him. - SECTION 26. G.S. 130A-119 reads as rewritten:

# "§ 130A-119. Clerk of Court to furnish State Registrar with facts as to paternity of illegitimate children born out of wedlock when judicially determined.

3 Upon the entry of a judgment determining the paternity of an illegitimate child, a child born 4 out of wedlock, the clerk of court of the county in which the judgment is entered shall notify 5 the State Registrar in writing of the name of the person against whom the judgment has been 6 entered, together with the other facts disclosed by the record as may assist in identifying the 7 record of the birth of the child as it appears in the office of the State Registrar. If the judgment 8 is modified or vacated, that fact shall be reported by the clerk to the State Registrar in the same 9 manner. Upon receipt of the notification, the State Registrar shall record the information upon 10 the birth certificate of the illegitimate child."

### SECTION 27. G.S. 143-166.2(a) and (c) read as rewritten:

12 "(a) The term "dependent child" shall mean any unmarried child of the deceased officer, 13 fireman, rescue squad worker or senior member of the Civil Air Patrol whether natural, 14 adopted, posthumously born or whether an illegitimate a child born out of wedlock as entitled 15 to inherit under the Intestate Succession Act, who is under 18 years of age and dependent upon 16 and receiving his chief support from said officer or fireman or rescue squad worker or senior 17 member of the Civil Air Patrol at the time of his death; provided, however, that if a dependent 18 child is entitled to receive benefits at the time of the officer's or fireman's or rescue squad 19 worker's or senior Civil Air Patrol member's death as hereinafter provided, he shall continue to 20 be eligible to receive such benefits regardless of his age thereafter; and further provided that 21 any child over 18 years of age who is physically or mentally incapable of earning a living and 22 any child over 18 years of age who was enrolled as a full-time student at the time of the 23 officer's, the fireman's, the rescue squad worker's or the senior Civil Air Patrol member's death 24 shall so long as he remains a full-time student as defined in the Social Security Act be regarded 25 as a dependent child and eligible to receive benefits under the provisions of this Article.

27 The term "killed in the line of duty" shall apply to any law-enforcement officer, (c) 28 fireman, rescue squad worker who is killed or dies as a result of bodily injuries sustained or of 29 extreme exercise or extreme activity experienced in the course and scope of his official duties 30 while in the discharge of his official duty or duties. When applied to a senior member of the 31 Civil Air Patrol as defined in this Article, "killed in the line of duty" shall mean any such senior member of the North Carolina Wing-Civil Air Patrol who is killed or dies as a result of bodily 32 33 injuries sustained or of extreme exercise or extreme activity experienced in the course and 34 scope of his official duties while engaged in a State requested and approved mission pursuant 35 to Article 11 of Chapter 143B [Article 13 of Chapter 143B] Article 13 of Chapter 143B of the 36 General Statutes. For purposes of this Article, when a law enforcement officer, fireman, rescue 37 squad worker, or senior Civil Air Patrol member dies as the direct and proximate result of a 38 myocardial infarction suffered while on duty or within 24 hours after participating in a training 39 exercise or responding to an emergency situation, the law enforcement officer, fireman, rescue 40 squad worker, or senior Civil Air Patrol member is presumed to have been killed in the line of 41 duty."

## 42 **SECTION 28.** This act is effective when it becomes law, and Sections 9 and 13 of 43 this act apply to estates of persons dying on or after that date.
