9 by rules of the Wildlife Resources Commission. This license remains valid

33 Fishing License. – \$30.00. This license shall be issued only to an  
34 individual who is ~~6570~~ years of age or older and who is a resident of  
35 the State.

36 f. Resident Disabled Veteran Lifetime Unified Sportsman/Coastal  
37 Recreational Fishing License. – \$110.00. This license shall be issued  
38 only to an individual who is a resident of the State and who is a fifty  
39 percent (50%) or more disabled veteran as determined by the United  
40 States Department of Veterans ~~Affairs.~~Affairs or as established by  
41 rules of the Wildlife Resources Commission. This license remains  
42 valid for the lifetime of the licensee so long as the licensee remains
