1 A BILL TO BE ENTITLED
2 AN ACT TO REPEAL THE REQUIREMENT THAT LOCAL GOVERNMENTS DEVELOP
3 AND MAINTAIN A SOLID WASTE MANAGEMENT PLAN.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 130A-309.09A reads as rewritten:

6 "**§ 130A-309.09A. Local government solid waste responsibilities.**

7 (a) The governing board of each unit of local government shall assess local solid waste
8 collection services and disposal capacity and shall determine the adequacy of collection
9 services and disposal capacity to meet local needs and to protect human health and the
10 environment. Each unit of local government shall implement programs and take other actions
11 that it determines are necessary to address deficiencies in service or capacity required to meet
12 local needs and to protect human health and the environment. A unit of local government may
13 adopt ordinances governing the disposal, in facilities that it operates, of solid waste generated
14 outside of the area designated to be served by the facility. Such ordinances shall not be
15 construed to apply to privately operated disposal facilities located within the boundaries of the
16 unit of local government.

17 (b) ~~Each unit of local government, either individually or in cooperation with other units~~
18 ~~of local government, shall develop a 10 year comprehensive solid waste management~~
19 ~~plan. Units of local government shall make a good-faith effort to achieve the State's forty~~
20 ~~percent (40%) municipal solid waste reduction goal and to comply with the State's~~
21 ~~comprehensive solid waste management plan. Each unit of local government shall develop its~~
22 ~~solid waste management plan with public participation, including, at a minimum, one~~
23 ~~advertised public meeting. The Department shall assist units of local government in the~~
24 ~~preparation of the plan required by this subsection if the unit of local government requests~~
25 ~~assistance. Each plan shall be updated at least every three years. In order to assure compliance~~
26 ~~with this subsection, each unit of local government shall provide the Department with a copy of~~
27 ~~its current plan upon request by the Department. Each plan shall:~~

28 (1) Evaluate the solid waste stream in the geographic area covered by the plan.

2 ~~basis by 30 June 2001 and a goal for the further reduction of municipal solid~~
3 ~~waste by 30 June 2006. The solid waste reduction goals shall be determined~~
4 ~~by the unit or units of local government that prepare the plan, and shall be~~
5 ~~determined so as to assist the State, to the maximum extent practical, to~~
6 ~~achieve the State's forty percent (40%) municipal solid waste reduction goal~~
7 ~~as set out in G.S. 130A-309.04(e).~~
8 (3) ~~Be designed to achieve the solid waste reduction goals established by the~~

10 (4) ~~Include a description of the process by which the plan was developed,~~
11 ~~including provisions for public participation in the development of the plan.~~

13 ~~actions with respect to the following solid waste management methods:~~

36 ~~waste that may be available through private enterprise.~~
37 (9) ~~(Expires October 1, 2023) Include as a component a written plan for the~~
38 ~~management of abandoned manufactured homes as required under~~
39 ~~G.S. 130A-309.113(a).~~
40 (d) In order to assess the progress in meeting the goal set out in G.S. 130A-309.04, each
41 unit of local government shall report to the Department on the solid waste management
42 programs and waste reduction activities within the unit of local government by 1 September of
43 each year. At a minimum, the report shall include:
44 (1) A description of public education programs on recycling.
45 (2) The amount of solid waste received at municipal solid waste management
46 facilities, by type of solid waste.
47 (3) The amount and type of materials from the solid waste stream that were
48 recycled.
49 (4) The percentage of the population participating in various types of recycling
50 activities instituted.

- 1 (5) The annual reduction in municipal solid waste, measured as provided in
 2 G.S. 130A-309.04.
 3 ~~(6) Information regarding programs and other actions implemented as part of the~~
 4 ~~local comprehensive solid waste management plan.~~
 5 (7) A statement of the costs of solid waste management programs implemented
 6 by the unit of local government and the methods of financing those costs.
 7 (8) Information regarding permanent recycling programs for discarded computer
 8 equipment and televisions for which funds are received pursuant to
 9 G.S. 130A-309.137, and information on operative interlocal agreements
 10 executed in conjunction with funds received, if any.
 11 (9) A description of the disaster debris management program.
 12 (10) A description of scrap tire disposal procedures.
 13 (11) A description of white goods management procedures.
 14 (12) Information regarding the prevention of illegal disposal and management of
 15 litter.

17 **SECTION 2.** G.S. 130A-309.09B(a) reads as rewritten:

18 **"§ 130A-309.09B. Local government waste reduction programs.**

19 (a) Each unit of local government shall establish and maintain a solid waste reduction
 20 ~~program that will enable the unit of local government to meet the local solid waste reduction~~
 21 ~~goals established pursuant to G.S. 130A-309.09A(b)(2) program.~~ The following requirements
 22 shall apply:

24 **SECTION 3.** G.S. 130A-309.09C(g) reads as rewritten:

25 **"§ 130A-309.09C. Additional powers of local governments; construction of this Part;**
 26 **effect of noncompliance.**

27 ...

28 (g) In addition to any other penalties provided by law, a unit of local government that
 29 does not comply with the requirements of ~~G.S. 130A-309.09A(b)~~G.S. 130A-309.09A(b),
 30 G.S. 130A-309.09A(d), and G.S. 130A-309.09B(a) shall not be eligible for grants from the
 31 Solid Waste Management Trust Fund, the Scrap Tire Disposal Account, or the White Goods
 32 Management Account and shall not receive the proceeds of the scrap tire disposal tax imposed
 33 by Article 5B of Chapter 105 of the General Statutes or the proceeds of the white goods
 34 disposal tax imposed by Article 5C of Chapter 105 of the General Statutes to which the unit of
 35 local government would otherwise be entitled. The Secretary shall notify the Secretary of
 36 Revenue to withhold payment of these funds to any unit of local government that fails to
 37 comply with the requirements of ~~G.S. 130A-309.09A(b)~~G.S. 130A-309.09A(b),
 38 G.S. 130A-309.09A(d), and G.S. 130A-309.09B(a). Proceeds of the scrap tire disposal tax that
 39 are withheld pursuant to this subsection shall be credited to the Scrap Tire Disposal Account
 40 and may be used as provided in G.S. 130A-309.63. Proceeds of the white goods disposal tax
 41 that are withheld pursuant to this subsection shall be credited to the White Goods Management
 42 Account and may be used as provided in G.S. 130A-309.83."

43 **SECTION 4.** G.S. 130A-309.58(d) reads as rewritten:

44 **"§ 130A-309.58. Disposal of scrap tires.**

45 ...

46 (d) Each county is responsible for developing a description of scrap tire disposal
 47 procedures. ~~These procedures shall be included in any solid waste management plan required~~
 48 ~~by the Department under this Article. These procedures shall be included in the annual report~~
 49 ~~required under G.S. 130A-309.09A.~~ Further, any revisions to the initial description of the scrap
 50 tire disposal procedures shall be forwarded to the Department."

51 **SECTION 5.** G.S. 130A-309.81(c) reads as rewritten:

1 **"§ 130A-309.81. Management of discarded white goods; disposal fee prohibited.**

2 ...
3 (c) Plan. – Each county shall establish written procedures for the management of white
4 goods. ~~The county shall include the procedures in any solid waste management plan required~~
5 ~~by the Department under this Article. These procedures shall be included in the annual report~~
6 required under G.S. 130A-309.09A."

7 **SECTION 6.** G.S. 130A-309.113(a) reads as rewritten:

8 **"§ 130A-309.113. (Effective July 1, 2009, and expiring October 1, 2023) Management of**
9 **abandoned manufactured homes.**

10 (a) Plan. – Each county shall consider whether to implement a program for the
11 management of abandoned manufactured homes. ~~If, after consideration, the county decides not~~
12 ~~to implement a program, the county must state in the comprehensive solid waste management~~
13 ~~plan that it is required to develop under G.S. 130A-309.09A(b) that the county considered~~
14 ~~whether to implement a program for the management of abandoned manufactured homes and~~
15 ~~decided not to do so. A county may, at any time, reconsider its decision not to implement a~~
16 ~~program for the management of abandoned manufactured homes. If~~ If at any time the county
17 decides to implement a program, the county shall develop a written plan for the management of
18 abandoned manufactured homes ~~and include the plan as a component of the comprehensive~~
19 ~~solid waste management plan it is required to develop under G.S. 130A-309.09A(b).~~ homes.
20 This plan shall be included in the annual report required under G.S. 130A-309.09A. At a
21 minimum, the plan shall include:

- 22 (1) A method by which the county proposes to identify abandoned manufactured
23 homes in the county, including, without limitation, a process by which
24 manufactured home owners or other responsible parties may request
25 designation of their home as an abandoned manufactured home.
- 26 (2) A plan for the deconstruction of these abandoned manufactured homes.
- 27 (3) A plan for the removal of the deconstructed components, including mercury
28 switches from thermostats, for reuse or recycling, as appropriate.
- 29 (4) A plan for the proper disposal of abandoned manufactured homes that are
30 not deconstructed under subdivision (2) of this subsection."

31 **SECTION 7.** G.S. 130A-309.137 reads as rewritten:

32 **"§ 130A-309.137. (See editor's note) Electronics Management Fund.**

34 (c) Eligibility. – Except as provided in subsection (d) of this section, no more than one
35 unit of local government per county, including the county itself, may receive funding pursuant
36 to this section for a program to manage discarded computer equipment, televisions, and other
37 electronic devices. ~~In order to be eligible for funding, a~~ A unit of local government ~~shall~~ shall
38 submit a plan to include:

- 39 (1) ~~Submit a comprehensive solid waste management plan required pursuant to~~
40 ~~G.S. 130A-309.09A, amended as necessary to include the following~~
41 ~~information:~~
 - 42 a. Information on existing programs within the jurisdiction to recycle or
43 reuse discarded computer equipment, televisions, and other
44 electronic devices, or information on a plan to begin such a program
45 on a date certain. This information shall include a description of the
46 implemented or planned practices for collection of the equipment and
47 a description of the types of equipment to be collected and how the
48 equipment will be marketed for recycling.
 - 49 (2) b. Information on a public awareness and education program
50 concerning the recycling and reuse of discarded computer equipment,
51 televisions, and other electronic devices.

governed by G.S. 130A-301.3. The Department shall not approve an application for a new permit, the renewal of a permit, or a substantial amendment to a permit for a sanitary landfill, excluding demolition landfills as defined in the rules of the Commission, except as provided in subdivisions (3) and (4) of subsection (b1) of this section. No permit shall be granted for a solid waste management facility having discharges that are point sources until the Department has referred the complete plans and specifications to the Environmental Management Commission and has received advice in writing that the plans and specifications are approved in accordance with the provisions of G.S. 143-215.1. ~~If the applicant is a unit of local government, and has not submitted a solid waste management plan that has been approved by the Department pursuant to G.S. 130A-309.09A(b), the Department may deny a permit for a sanitary landfill or a facility that disposes of solid waste by incineration, unless the Commission has not adopted rules pursuant to G.S. 130A-309.29 for local solid waste management plans.~~ In any case where the Department denies a permit for a solid waste management facility, it shall state in writing the reason for denial and shall also state its estimate of the changes in the applicant's proposed activities or plans that will be required for the applicant to obtain a permit.

A person who intends to apply for a new permit, the renewal of a permit, or a substantial amendment to a permit for a sanitary landfill shall obtain, prior to applying for a permit, a franchise for the operation of the sanitary landfill from each local government having jurisdiction over any part of the land on which the sanitary landfill and its appurtenances are located or to be located. A local government may adopt a franchise ordinance under G.S. 153A-136 or G.S. 160A-319. A franchise granted for a sanitary landfill shall include all of the following:

- a. A statement of the population to be served, including a description of the geographic area.
- b. A description of the volume and characteristics of the waste stream.
- c. A projection of the useful life of the sanitary landfill.
- d. ~~An explanation of how the franchise will be consistent with the jurisdiction's solid waste management plan required under G.S. 130A-309.09A, including provisions for waste reduction, reuse, and recycling.~~
- e. The procedures to be followed for governmental oversight and regulation of the fees and rates to be charged by facilities subject to the franchise for waste generated in the jurisdiction of the franchising entity.
- f. A facility plan for the sanitary landfill that shall include the boundaries of the proposed facility, proposed development of the facility site in five-year operational phases, the boundaries of all waste disposal units, final elevations and capacity of all waste disposal units, the amount of waste to be received per day in tons, the total waste disposal capacity of the sanitary landfill in tons, a description of environmental controls, and a description of any other

1 waste management activities to be conducted at the facility. In
2 addition, the facility plan shall show the proposed location of soil
3 borrow areas, leachate facilities, and all other facilities and
4 infrastructure, including ingress and egress to the facility.

6 **SECTION 9.** This act is effective when it becomes law.
