4 "TO ALLOW A CHARTER SCHOOL TO EXPAND ONE GRADE HIGHER THAN THE  
5 CHARTER SCHOOL CURRENTLY OFFERS;"

7 and on page 2, lines 29-30, by inserting the following:

9 **"SECTION 2.5.(a) G.S. 115C-238.29D(f) reads as rewritten:**

10 "(f) It shall not be considered a material revision of a charter application and shall not  
11 require prior approval of the State Board for a charter school to do any of the following:

- 12 (1) Increase its enrollment during the charter school's second year of operation  
13 and annually thereafter by up to twenty percent (20%) of the school's  
14 previous year's enrollment.
- 15 (2) Increase its enrollment during the charter school's second year of operation  
16 and annually thereafter in accordance with planned growth as authorized in  
17 its charter.
- 18 (3) Expand to offer one grade higher than the charter school currently offers if  
19 the charter school has operated for at least three years and has not been  
20 identified as having inadequate performance as provided in  
21 G.S. 115C-238.29G(a1).
- 22 (4) Expand to offer one grade higher than the charter school currently offers. A  
23 charter school shall not increase enrollment in an expansion grade level  
24 added pursuant to this subdivision."

25 **SECTION 2.5.(b)** This section is effective when it becomes law and applies  
26 beginning with the 2015-2016 school year. G.S. 115C-238.29D(f)(4), as enacted by this  
27 section, expires July 1, 2018 and does not apply to the 2017-2018 school year.";
