A student subject to an absence under G.S. 130A-440 shall be provided the following: 28 The opportunity to take textbooks home for the duration of the absence. 29 (1)30 (2)Upon request, the right to receive all missed assignments and, to the extent 31 practicable, the materials distributed to students in connection with the assignment. 32
