## March 16, 2015 1 A BILL TO BE ENTITLED 2 AN ACT TO DIRECT THE DEPARTMENT OF TRANSPORTATION TO STUDY THE 3 BICYCLE SAFETY LAWS IN THIS STATE AND MAKE RECOMMENDATIONS AS 4 TO HOW THE LAWS MAY BE REVISED TO BETTER ENSURE THE SAFETY OF 5 BICYCLISTS AND MOTORISTS ON THE ROADWAYS. 6 The General Assembly of North Carolina enacts: 7 SECTION 1. Study. - The Department of Transportation shall study the bicycle 8 safety laws in this State. The study shall focus on what statutory revisions, if any, are needed to better ensure the safety of bicyclists and motorists. In doing so, the Department shall consider 9 10 at least all of the following: 11 How faster-moving vehicles may safely overtake bicycles on roadways (1)12 where sight distance may be inhibited. Whether bicyclists on a roadway should be required to ride single file or 13 (2)14 allowed to ride two or more abreast. Whether bicyclists should be required to carry a form of identification. 15 (3) Any other issues determined relevant by the Department. 16 (4) 17 SECTION 2. Working Group. – In conducting the study required by this act, the 18 Department shall convene a working group of interested parties knowledgeable and interested 19 in the bicycle safety laws of this State. The working group shall include all of the following: 20 (1)A law enforcement officer. A representative from the bicycling industry. 21 (2)A representative from the agricultural industry. 22 (3) 23 A representative from the trucking industry. (4) A representative from county government, who may be a county law 24 (5) 25 enforcement officer. 26 A representative from municipal government, who may be a municipal law (6) 27 enforcement officer. 28 A representative from the University of North Carolina Highway Safety (7)29 Research Center. 30 (8) A minimum of two staff representatives from the Department. Any other expert or stakeholder the Department or working group 31 (9) 32 determines may assist the Department in completing the study required by 33 this act. 34 The Department shall designate the members listed in subdivisions (1) through (8) of this section, and the working group shall subsequently select a chair and designate the 35

remaining members of the working group authorized under subdivision (9) of this section. In 36

designating additional members, the working group shall ensure that membership composition
includes representation of different operator and geographical perspectives.

3 SECTION 3. Maximum Number of Working Group Members. – The total number
4 of members of the working group convened under Section 2 of this act shall not exceed 12
5 members.

6 **SECTION 4.** Report and Recommendations. – The Department shall report its 7 findings and recommendations, including any legislative proposals, to the Joint Legislative 8 Transportation Oversight Committee on or before December 31, 2015.

**SECTION 5.** Effective Date. – This act is effective when it becomes law.
