1 moves to amend the bill on page 463, lines 12-15, by rewriting the lines to read:
2 "satisfying the wage standard as set out in the table below. If the project will be located in more
3 than one development tier area, the location with the highest development tier area designation
4 determines the minimum number of eligible positions that must be created. The wage standard
5 is met if the business pays";

7 and on page 465, lines 17-18, by inserting between the lines the following language to read:
8 "SECTION 32.11.(e1) Article 10 of Chapter 143B of the General Statutes is
9 amended by adding a new section to read:

10 "§ 143B-437.56A. Multi-location projects.

11 (a) Except as provided in subsection (b) of this section, if a project will be located in
12 more than one development tier area, the location with the highest area designation determines
13 the standards applicable under this Part to the project.

14 (b) For purposes of G.S. 143B-437.56(d), if a project will be located in more than one
15 development tier area, the location with the lowest area designation determines the percentage
16 of the annual grant approved for disbursement payable to the Utility Account pursuant to
17 G.S. 143B-437.61 if (i) the project will have at least one location in a major market community
18 or development tier three area, (ii) the project will have at least one location in a development
19 tier one or two area, and (iii) at least sixty-six percent (66%) of the number of eligible positions
20 created or the total benefits of the project to the State, as calculated pursuant to
21 G.S. 143B-437.52, or both are located in the lowest area designation.";

23 on page 463, line 27, by deleting "250" and substituting "200";

25 and on page 465, line 13, by rewriting the line to read:
26 "exceeds seventy-five percent (75%) the applicable maximum percentage of the withholdings of
27 the business, as provided in subsections (a) and (a1) of this section, unless the Committee".
