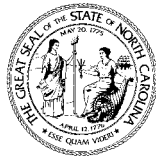

1 moves to amend the bill on page 1, line 4, by rewriting the line to read:

3 "AGREEMENT FOR OFFICE PRODUCTIVITY SOFTWARE FOR PUBLIC SCHOOLS, TO
4 ADOPT RULES AND POLICIES LIMITING THE NONINSTRUCTIONAL DUTIES OF
5 TEACHERS,";

7 and on page 1, lines 17-18, by inserting the following between those lines:

9 **"SECTION 1.2.(a)** SECTION 8.45. of S.L. 2015-241 is repealed.

10 **SECTION 1.2.(b)** G.S. 115C-47(18a) reads as rewritten:

11 "(18a) To Adopt Rules and Policies Limiting the Noninstructional Duties of
12 Teachers. – Local boards of education shall adopt rules and policies limiting
13 the noninstructional duties assigned to teachers. A local board may
14 temporarily suspend the rules and policies for individual schools upon a
15 finding that there is a compelling reason the rules or policies should not be
16 implemented. These rules and policies shall ensure that:

17 a. Teachers with initial certification are not assigned extracurricular
18 activities unless they request the assignments in writing and that
19 other noninstructional duties assigned to these teachers are
20 minimized, so these teachers have an opportunity to develop into
21 skilled ~~professionals~~; professionals.

22 b. Teachers with 27 or more years of experience are not assigned
23 extracurricular activities unless ~~they request the assignments in~~
24 ~~writing and that other noninstructional duties assigned to these~~
25 ~~teachers are minimized, those teachers' absence from participation~~
26 would prevent the safe and effective operation of the school. Non-
27 instructional duties assigned to these teachers shall be minimized so
28 these teachers have an opportunity to informally share their
29 experience and expertise with their ~~colleagues~~; colleagues.

30 c. The noninstructional duties of all teachers are limited to the extent
31 possible given federal, State, and local laws, rules, and policies, and
