Moves to amend the bill on page 45, line 35 through page 46, line 6,

By rewriting those lines to read as follows:

"SECTION 11.4.(c) NC Promise Tuition Plan – Article 14 of Chapter 116 of the General Statutes is amended by adding a new section to read:

#### "§ 116-143.10. NC Promise Tuition Plan.

- (a) Notwithstanding G.S. 116-143 and G.S. 116-11(7), the Board of Governors of The University of North Carolina shall set tuition rates for the University of North Carolina at Pembroke and Western Carolina University as follows: Beginning with the 2018 fall academic semester, the tuition rate for resident students shall be five hundred dollars (\$500.00) per academic semester and the tuition rate for nonresident students shall be two thousand five hundred dollars (\$2,500) per academic semester.
- (b) Notwithstanding any other provision of law, beginning with the 2018-2019 fiscal year, the Director of the Budget shall authorize an increase in the base budget of The University of North Carolina for a fiscal year as provided by this subsection upon notification by the Chancellor of the University of North Carolina at Pembroke or the Chancellor of Western Carolina that additional funds are needed by the constituent institution to cover the cost of a tuition revenue loss for the fiscal year due to the tuition rate established in subsection (a) of this section. The Chancellor requesting the additional funds shall provide any information requested by the Director of the Budget to document the amount of the tuition revenue loss due to the tuition rate and the need for additional funds required by the constituent institution. The Director of the Budget shall authorize an increase in the base budget of The University of North Carolina for the appropriate fiscal year determined by the Director to be equal to the tuition revenue loss and shall allocate those funds to the constituent institution. The Director shall report the authorization of any increase in the base budget and allocation of funds made pursuant to this subsection to the Joint Legislative Commission on Governmental Operations at its next meeting.

Any increase in the base budget authorized pursuant to this subsection shall not be included in the calculation of projected enrollment growth under G.S. 116-30.7. The authorization provided in this subsection shall be effective only as long as tuition continues at the rate established by subsection (a) of this section.";
