The conferees appointed to resolve the differences between the Senate and the House of Representatives on Senate Bill 8. A BILL TO BE ENTITLED AN ACT TO PROVIDE AN EXEMPTION TO BUILDING CODE PROVISIONS ALLOWING CONSTRUCTION OF A PARKING GARAGE TO EXTEND ACROSS A LOT LINE BETWEEN A CITY-OWNED LOT AND A PRIVATELY OWNED LOT WITHOUT MEETING CERTAIN REQUIREMENTS; TO RESTRICT THE STORMWATER RUNOFF REQUIREMENTS THAT A LOCAL GOVERNMENT CAN APPLY TO PUBLIC AIRPORTS; TO REQUIRE NONPUBLIC SCHOOLS THAT ACCEPT STUDENTS RECEIVING SCHOLARSHIP GRANTS TO SUBMIT BACKGROUND CHECKS ON EMPLOYEES TO THE STATE EDUCATION ASSISTANCE AUTHORITY; AND TO REVISE THE COMPOSITION OF THE LINCOLNTON-LINCOLN AIRPORT AUTHORITY, TO NAME THE AIRPORT, AND TO NAME THE AIRFIELD WITHIN THE AIRPORT, House Committee Substitute Favorable 6/29/17, submit the following report:
