Sponsors: Referred to: A BILL TO BE ENTITLED 1 2 AN ACT TO REQUIRE THE DEPARTMENT OF PUBLIC SAFETY TO DEVELOP A ROSTER OF HANDGUNS THAT MEET CERTAIN DESIGN AND SAFETY 3 4 STANDARDS AND TO PROHIBIT THE SALE, TRANSFER, OWNERSHIP, OR 5 POSSESSION OF HANDGUNS THAT ARE NOT INCLUDED ON THE ROSTER. 6 The General Assembly of North Carolina enacts: 7 **SECTION 1.** Article 52A of Chapter 14 of the General Statutes is amended by 8 adding a new section to read: 9 "§ 14-406.2. Prohibition on sale, transfer, ownership, or possession of unsafe handgun. Findings. – The General Assembly finds all of the following: 10 (a) 11 There is a lack of design and safety standards imposed on pistols under federal (1)12 and State law. 13 (2)A lack of design and safety standards results in the sale of poorly constructed pistols, which can lead to unintentional shootings and other harms. 14 15 Multiple states have utilized the following design and safety tests performed (3) by independent handgun testing laboratories to develop rosters of handguns 16 17 that satisfy the tests and are approved for sale within the state's jurisdiction: Firing tests. 18 <u>a.</u> 19 b. Drop tests. 20 Melting point tests. с. 21 It is in the public interest to ensure, in a timely manner, that handguns that do (4)22 not meet design and safety standards are not sold, transferred, owned, or 23 possessed in this State. 24 The most efficient and expeditious method for ensuring unsafe handguns are (5) 25 not sold in this State is to develop a roster of approved handguns for sale in this State that is based off the rosters developed in other states. 26 Definitions. – The following definitions apply in this section: 27 (b) 28 Antique firearm. – As defined in G.S. 14-409.11. (1)29 (2) California Roster of Handguns Certified for Sale. - A roster complied by the 30 Department of Justice for the State of California pursuant to California Penal 31 Code § 12131 that lists all of the pistols, revolvers, and other firearms that have been tested by a certified testing laboratory and determined not to be 32 33 unsafe. 34 Dealer. – As defined in G.S. 14-409.39. 1	(h) Dissemination. – At least 30 days prior to the date a roster developed and updated in
2	accordance with this section is to take effect, the Department shall publish the roster and any
3	updates on its Web site.
4	(i) <u>Penalty. – Any person violating the provisions of subsections (c) and (d) of this</u>
5	section is guilty of a Class 3 misdemeanor."
6	SECTION 2. The initial roster developed under G.S. 14-406.2(c), as enacted by
7	Section 1 of this act, shall be based on the California Roster of Handguns Certified for Sale as of
8	January 1, 2019.
9	SECTION 3. By January 15, 2019, the Department of Public Safety shall (i) submit
10	a report to the Joint Legislative Oversight Committee on Justice and Public Safety detailing the
11	development of the roster required under G.S. 14-406.2(c), as enacted by Section 1 of this act,
12	and the types of handguns that are included on the roster and (ii) publish the roster on its Web
13	site in accordance with G.S. 14-406.2(c).
14	SECTION 4. There is appropriated from the General Fund to the Department of
15	Public Safety the sum of twenty-five thousand dollars (\$25,000) in nonrecurring funds for the
16	2018-2019 fiscal year to use to cover any costs incurred in meeting the requirements set forth in
17	G.S. 14-406.2, as enacted by Section 1 of this act.
18	SECTION 5. The provisions of G.S. 143C-5-2 do not apply to this act.
19	SECTION 6. Sections 4 through 6 of this act become effective July 1, 2018. The
20	remainder of this act becomes effective January 1, 2019.
