SECTION 4. If Senate Bill 99, 2017 Regular Session, becomes law, The Director of the Budget shall increase the budget of the Administrative Office of the Courts from the unserved fund balance in an amount sufficient to cover the costs of the judgeships created by this bill. These funds are hereby appropriated.

5 **SECTION 5.** This act is effective when it becomes law, and elections in 2018 and 6 thereafter shall be held accordingly.
