section shall nominate persons to fill vacancies created by resignation or removal in the same manner as the member was originally selected.

SECTION 2. Chairs; meetings; quorum. – The President Pro Tempore of the Senate and the Speaker of the House of Representatives must each designate a cochair of the Committee. The Committee shall meet upon the joint call of the cochairs. A quorum of the Committee is a majority of its members.

SECTION 3. Purpose. – The Committee is directed to study what is needed to keep North Carolina at the forefront of emerging biomanufacturing technologies and job creation, including all of the following:

Estimates of current and future biomanufacturing workforce needs and (1) identification of existing and potential bottlenecks that would limit or hinder meeting those needs.

(2) Estimates of current and future biomanufacturing water and wastewater needs and identification of existing and potential bottlenecks that would limit or hinder meeting those needs.

Assessment and characterization of the State's existing biomanufacturing (3) workforce education and training assets, together with an estimate of future workforce training needs and identification of investments in personnel, facilities, and equipment needed to meet those needs.

(4) Identification of locations in the State that can readily accommodate new biomanufacturing operations.

Identification of existing and emerging wastewater treatment strategies and (5) technologies that can be used to meet the State's biomanufacturing wastewater treatment needs and remove bottlenecks identified in subdivision (2) of this section.

(6) Any other recommendations as the Committee considers appropriate to support the future growth of North Carolina's biomanufacturing sector.

SECTION 4. Per diem; staff. – Members of the Committee receive per diem, subsistence, and travel allowance as provided in G.S. 120-3.1, 138-5, or 138-6, as appropriate. The Legislative Services Officer shall assign professional and clerical staff to assist the Committee in its work.

SECTION 5. Report. – The Committee may submit an interim report to the 2019 Regular Session of the General Assembly prior to its reconvening in 2020 and shall make a final report to the 2021 Regular Session of the General Assembly prior to its first convening after adjourning its organizational session. The Committee shall also submit its report to the Secretary of Commerce, the Secretary of Environmental Quality, the President of The University of North Carolina, the President of the North Carolina Community College System, and other entities as may be designated by the cochairs, the Speaker of the House, or the President Pro Tempore of the Senate.

SECTION 6. Termination. – The Committee terminates when the 2021 Regular Session of the General Assembly first convenes after adjourning its organizational session or upon the filing of its final report, whichever occurs first.

SECTION 7.(a) Definitions. – "Nonpoint Source Allocation Purchase Rule" means items (7)(b) and (8)(d) of 15A NCAC 02B .0234 (Neuse River Basin-Nutrient Sensitive Waters Management Strategy: Wastewater Discharge Requirements) for purposes of this section and its implementation.

SECTION 7.(b) Nonpoint Source Allocation Purchase Rule. – Until the effective date of the revised permanent rule that the Environmental Management Commission is required

to adopt pursuant to subsection (d) of this section, the Commission and local air permitting programs shall implement the Nonpoint Source Allocation Purchase Rule as provided in subsection (c) of this section.

 SECTION 7.(c) Implementation. – In cases where new and expanding wastewater treatment facilities cannot obtain estuary point source allocation and must purchase a portion of the nonpoint source load allocation, the purchase rate shall be one hundred ten percent (110%) of the cost as set in 15A NCAC 02B .0240.

 SECTION 7.(d) Additional Rule-Making Authority. – The Commission shall adopt a rule to amend the Nonpoint Source Allocation Purchase Rule consistent with subsection (c) of this section. Notwithstanding G.S. 150B-19(4), the rule adopted by the Commission pursuant to this subsection shall be substantively identical to the provisions of subsection (c) of this section. Rules adopted pursuant to this section are not subject to Part 3 of Article 2A of Chapter 150B of the General Statutes. Rules adopted pursuant to this section shall become effective as provided in G.S. 150B-21.3(b1) as though 10 or more written objections had been received as provided in G.S. 150B-21.3(b2).

SECTION 7.(e) Sunset. – This section expires when permanent rules adopted as required by subsection (d) of this section become effective.

SECTION 7.(f) This section is effective when it becomes law.

SECTION 8. Section 7 of this act is effective when it becomes law. The remainder of this act is effective July 1, 2019.
