2	AN ACT TO PROVIDE A MINIMUM OF THIRTY MINUTES OF DUTY-FREE LUNCH		
3	TIME FOR TEACHERS TO THE EXTENT POSSIBLE.		
4	The General Assembly of North Carolina enacts:		
5	SECTION 1. G.S. 115C-301.1 reads as rewritten:		
6	"§ 115C-301.1. Duty-free instructional planning <u>and lunch</u> time.		
7	(a) <u>All-During regular student contact hours all full-time assigned classroom teachers</u>		
8 9	shall be provided with both of the following:		
9 10	(1) duty-free Duty-free instructional planning time during regular student contact hours.time.		
10	(2) At least 30 minutes of duty-free lunch time on a daily basis.		
12	(b) The duty-free instructional planning time and duty-free lunch shall be provided to the		
13	maximum extent that (i) the safety and proper supervision of children may allow during regular		
14	student contact hours and (ii) insofar as funds are provided for this purpose by the General		
15	Assembly. If the safety and supervision of children does not allow duty-free instructional		
16	planning time and duty-free lunch during regular student contact hours for a given teacher, the		
17	funds provided by the General Assembly for the duty-free instructional planning time and		
18	duty-free lunch for that teacher shall revert to the general fund. Principals shall not unfairly		
19	burden a given teacher by making that teacher give up his or her duty-free instructional planning		
20	time or duty-free lunch on an ongoing, regular basis without the consent of the teacher."		
21	<b>SECTION 2.</b> G.S. 115C-105.27(b) reads as rewritten:		
22	"(b) School Improvement Plan. – In order to improve student performance, the school		
23	improvement team at each school shall develop a school improvement plan that takes into		
24 25	consideration the annual performance goal for that school that is set by the State Board under		
25 26	G.S. 115C-105.35 and the goals set out in the mission statement for the public schools adopted		
26 27	by the State Board of Education. All school improvement plans shall be, to the greatest extent		
27	possible, data-driven. School improvement teams shall use the Education Value-Added		
28 29	Assessment System (EVAAS) or a compatible and comparable system approved by the State Board of Education to (i) analyze student data and identify root causes for problems. (ii)		
2) 30	Board of Education to (i) analyze student data and identify root causes for problems, (ii) determine actions to address them, and (iii) appropriately place students in courses such as		
31	Algebra I. School improvement plans shall contain clear, unambiguous targets, explicit indicators		
32	and actual measures, and expeditious time frames for meeting the measurement standards.		
33	The strategies for improving student performance:		
34	(1) Shall include a plan for the use of staff development funds that may be made		
35	available to the school by the local board of education to implement the school

18		teacher under G.S. 115C-301.1, with the goal of providing an average of at
19		least five hours of planning time per week; week.
20	(8)	Shall include a plan to identify and eliminate unnecessary and redundant
21		reporting requirements for teachers and, to the extent practicable, streamline
22		the school's reporting system and procedures, including requiring forms and
23		reports to be in electronic form when possible and incorporating relevant
24		documents into the student accessible components of the Instructional
25		Improvement System."
26		<b>TON 2.</b> This act is effective when it becomes law and applies beginning with
27	the 2019-2020 sc	hool year.
