3	SCHOOLS,	INCLUDING HOW TO INCORPORATE CAREER AND COLLEGE
4	READINESS	MEASURES INTO SCHOOL PERFORMANCE GRADES FOR HIGH
5	SCHOOLS.	
6	The General Assembly of North Carolina enacts:	
7	SECTION 1. There is established the Joint Legislative Study Committee on Career	
8	and College Readiness (Committee). The Committee shall consist of three members of the Senate	
9	appointed by the President Pro Tempore of the Senate and three members of the House of	
10	Representatives appointed by the Speaker of the House of Representatives. The President Pro	
11	Tempore of the Senate and the Speaker of the House of Representatives shall each appoint a	
12	cochair of the Committee from among its membership. Members shall serve at the pleasure of	
13	the appointing officer.	
14	SECT	FION 2. The Committee shall study and make recommendations on the
15	following:	
16	(1)	The meaning of career and college readiness and any specific skills that the
17		phrase should include.
18	(2)	How instruction in career and college readiness skills identified in subdivision
19		(1) should be incorporated into the standard course of study.
20	(3)	All relevant outcome measures that would determine the success of career and
21		college readiness programs in North Carolina public schools.
22	(4)	Different ways to include in high school performance grades the participation
23		and success in coursework that results in credit toward (i) college graduation
24		(such as dual enrollment, AP, or IB courses) or (ii) a valuable postsecondary
25		credential or certification recognized by one or more nationally recognized
26		business groups.
27	(5)	How other states have incorporated the coursework described in subdivision
28		(4) of this section into their school evaluation systems, including a review of
29		other states' Every Student Succeeds Act (ESSA) plans.
30	(6)	How various approaches for including such coursework in high school
31		performance grades would impact school performance grades across the State,
32		including sample calculations by the Department of Public Instruction.
33	(7)	Any other issue the Committee considers relevant to this study.
34	SECT	FION 3. The Committee shall meet upon the call of its cochairs. A quorum of
35	the Committee is a majority of its members. No action may be taken except by a majority vote	
36	at a meeting at which a quorum is present. The Committee, while in the discharge of its official

duties, may exercise all powers provided for under G.S. 120-19 and Article 5A of Chapter 120 of the General Statutes. The Committee may contract for professional, clerical, or consultant services, as provided by G.S. 120-32.02. Members of the Committee shall receive per diem, subsistence, and travel allowance as provided in G.S. 120-3.1. The expenses of the Committee shall be considered expenses incurred for the joint operation of the General Assembly.

6 **SECTION 4.** The Legislative Services Officer shall assign professional and clerical 7 staff to assist the Committee in its work. The Director of Legislative Assistants of the House of 8 Representatives and the Director of Legislative Assistants of the Senate shall assign clerical 9 support to staff the Committee.

10 SECTION 5. The Committee shall submit a final report on the results of its study, 11 including any proposed legislation, to the members of the Senate and the House of 12 Representatives on or before April 1, 2020, by filing a copy of the report with the Office of the 13 President Pro Tempore of the Senate, the Office of the Speaker of the House of Representatives, 14 the Joint Legislative Education Oversight Committee, and the Legislative Library. The 15 Committee shall terminate on April 1, 2020, or upon the filing of its final report, whichever 16 occurs first.

SECTION 6. This act is effective when it becomes law.
