2 AN ACT TO AMEND THE LICENSED PROFESSIONAL COUNSELORS ACT; TO  
3 UPDATE AND REVISE THE SUBSTANCE ABUSE PROFESSIONAL PRACTICE ACT;  
4 AND TO AMEND THE SOCIAL WORKER CERTIFICATION AND LICENSURE ACT.  
5 The General Assembly of North Carolina enacts:

7 **PART I. CHANGES TO THE LICENSED PROFESSIONAL COUNSELORS ACT**

8 **SECTION 1.(a)** Article 24 of Chapter 90 of the General Statutes reads as rewritten:

9 "Article 24.

10 "Licensed ~~Professional~~Clinical Mental Health Counselors Act.

11 **"§ 90-329. Declaration of policy.**

12 It is declared to be the public policy of this State that the activities of persons who render  
13 counseling services to the public be regulated to insure the protection of the public health, safety,  
14 and welfare.

15 **"§ 90-330. Definitions; practice of counseling.**

16 (a) Definitions. – ~~As used in this Article certain terms are defined as follows:~~The  
17 following definitions apply in this Article:

18 (1) Repealed by Session Laws 1993, c. 514, s. 1.

19 (1a) The "Board" means the Board of Licensed ~~Professional~~Clinical Mental  
20 Health Counselors.

21 (2) A "licensed ~~professional~~clinical mental health counselor" is a person engaged  
22 in the practice of counseling who holds a license as a licensed ~~professional~~  
23 clinical mental health counselor issued under the provisions of this Article.

24 (2a) A "licensed ~~professional~~clinical mental health counselor associate" is a  
25 person engaged in the supervised practice of counseling who holds a license  
26 as a licensed ~~professional~~clinical mental health counselor associate issued  
27 under the provisions of this Article.

28 (2b) A "licensed ~~professional~~clinical mental health counselor supervisor" is a  
29 person engaged in the practice of counseling who holds a license as a licensed  
30 ~~professional~~clinical mental health counselor and is approved by the Board to  
31 provide clinical supervision under the provisions of this Article.

32 (3) The "practice of counseling" means holding oneself out to the public as a  
33 ~~professional~~clinical mental health counselor offering counseling services that  
34 include, but are not limited to, the following:

1 The "practice of counseling" does not include the facilitation of  
2 communication, understanding, reconciliation, and settlement of conflicts by  
3 mediators at community mediation centers authorized by G.S. 7A-38.5.

4 (4) A "supervisor" means any licensed ~~professional~~clinical mental health  
5 counselor supervisor or, when one is inaccessible, a licensed ~~professional~~  
6 clinical mental health counselor or an equivalently and actively licensed  
7 mental health professional, as determined by the Board, who meets the  
8 qualifications established by the Board.

9 (b) Repealed by Session Laws 1993, c. 514, s. 1.

10 (c) Practice of Marriage and Family Therapy, Psychology, or Social Work. – No person  
11 licensed as a licensed ~~professional~~clinical mental health counselor or licensed ~~professional~~  
12 clinical mental health counselor associate under the provisions of this Article shall be allowed to  
13 hold himself or herself out to the public as a licensed marriage and family therapist, licensed  
14 practicing psychologist, psychological associate, or licensed clinical social worker unless  
15 specifically authorized by other provisions of law.

16 **"§ 90-331. Prohibitions.**

17 It shall be unlawful for any person who is not licensed under this Article to engage in the  
18 practice of counseling, use the title "Licensed ~~Professional~~Clinical Mental Health Counselor  
19 Associate," "Licensed ~~Professional~~Clinical Mental Health Counselor," or "Licensed  
20 ~~Professional~~Clinical Mental Health Counselor Supervisor," use the letters "~~LPCA,~~" "~~LPC,~~" or  
21 "~~LPCS,~~" "LCMHCA," "LCMHC," or "LCMHCS," use any facsimile or combination of these  
22 words or letters, abbreviations, or insignia, or indicate or imply orally, in writing, or in any other  
23 way that the person is a licensed ~~professional~~clinical mental health counselor.

24 **"§ 90-332. Use of title by firm.**

25 It shall be unlawful for any firm, partnership, corporation, association, or other business or  
26 professional entity to assume or use the title of licensed ~~professional~~clinical mental health  
27 counselor unless each of the members of the firm, partnership, or association is licensed by the  
28 Board.

29 **"§ 90-332.1. Exemptions from licensure.**

30 ...

31 (b) Persons who claim to be exempt under subsection (a) of this section are prohibited  
32 from advertising or offering themselves as "licensed ~~professional~~clinical mental health  
33 counselors".

34 ...

35 **"§ 90-333. North Carolina Board of Licensed ~~Professional~~Clinical Mental Health**  
36 **Counselors; appointments; terms; composition.**

37 (a) For the purpose of carrying out the provisions of this Article, there is hereby created  
38 the North Carolina Board of Licensed ~~Professional~~Clinical Mental Health Counselors which  
39 shall consist of seven members appointed by the Governor in the manner hereinafter prescribed.  
40 Any State or nationally recognized professional association representing ~~professional~~clinical  
41 mental health counselors may submit recommendations to the Governor for Board membership.  
42 The Governor may remove any member of the Board for neglect of duty or malfeasance or  
43 conviction of a felony or other crime of moral turpitude, but for no other reason.

44 (b) At least five members of the Board shall be licensed ~~professional~~clinical mental  
45 health counselors except that initial appointees shall be persons who meet the educational and  
46 experience requirements for licensure as licensed ~~professional~~clinical mental health counselors  
47 under the provisions of this Article; and two members shall be public-at-large members appointed  
48 from the general public. Composition of the Board as to the race and sex of its members shall  
49 reflect the population of the State and each member shall reside in a different congressional  
50 district.

1 (c) At all times the Board shall include at least one counselor primarily engaged in  
2 counselor education, at least one counselor primarily engaged in the public sector, at least one  
3 counselor primarily engaged in the private sector, and two licensed ~~professional-clinical mental~~  
4 health counselors at large.

5 ...

6 **"§ 90-334. Functions and duties of the Board.**

7 (a) The Board shall administer and enforce the provisions of this Article.

8 ...

9 (i) The Board shall establish the criteria for determining the qualifications constituting  
10 "supervised ~~professional-clinical mental health~~ practice".

11 (j) The Board may examine, approve, issue, deny, revoke, suspend, and renew the  
12 licenses of counselor applicants and licensees under this Article, and conduct hearings in  
13 connection with these actions.

14 (k) The Board shall investigate, subpoena individuals and records, and take necessary  
15 appropriate action to properly discipline persons licensed under this Article and to enforce this  
16 Article.

17 (l) The Board shall establish a program for licensees who may be experiencing substance  
18 use disorders, burnout, compassion fatigue, and other mental health concerns. In establishing this  
19 program, the Board is authorized to enter into agreements with existing professional health care  
20 programs. The Board is also authorized to refer any licensee to this program as part of the  
21 disciplinary process. The Board may adopt rules implementing this program.

22 **"§ 90-335. Board general provisions.**

23 The Board shall be subject to the provisions of Chapter 93B of the General Statutes.

24 **"§ 90-336. Title and qualifications for licensure.**

25 (a) Each person desiring to be a licensed ~~professional-clinical mental health~~ counselor  
26 associate, licensed ~~professional-clinical mental health~~ counselor, or licensed ~~professional-clinical~~  
27 mental health counselor supervisor shall make application to the Board upon such forms and in  
28 such manner as the Board shall prescribe, together with the required application fee.

29 (b) The Board shall issue a license as a "licensed ~~professional-clinical mental health~~  
30 counselor associate" to an applicant who applies on or before March 1, 2016, and meets all of  
31 the following criteria:

32 ...

33 (b1) The Board shall issue a license as a "licensed ~~professional-clinical mental health~~  
34 counselor associate" to an applicant who applies after March 1, 2016, through June 30, 2022, and  
35 meets all of the following criteria:

36 ...

37 (b2) The Board shall issue a license as a "licensed ~~professional-clinical mental health~~  
38 counselor associate" to an applicant who applies on or after July 1, 2022, and meets all of the  
39 following criteria:

40 ...

41 (c) The Board shall issue a license as a "licensed ~~professional-clinical mental health~~  
42 counselor" to an applicant who meets all of the following criteria:

43 (1) Has met all of the requirements under subsection (b), (b1), or (b2) of this  
44 section, as applicable.

45 (2) Has completed a minimum of 3,000 hours of supervised ~~professional-clinical~~  
46 mental health practice as determined by the Board.

47 (d) A licensed ~~professional-clinical mental health~~ counselor may apply to the Board for  
48 recognition as a "licensed ~~professional-clinical mental health~~ counselor supervisor" and receive  
49 the credential "licensed ~~professional-clinical mental health~~ counselor supervisor" upon meeting  
50 all of the following criteria:

51 (1) Has met all of the requirements under subsection (c) of this section.

- 1 (2) Has one of the following:
- 2 a. At least five years of full-time licensed ~~professional-clinical mental~~  
3 health counseling experience, including a minimum of 2,500 hours of  
4 direct client contact;
- 5 b. At least eight years of part-time licensed ~~professional-clinical mental~~  
6 health counseling experience, including a minimum of 2,500 hours of  
7 direct client contact; or
- 8 c. A combination of full-time and part-time ~~professional-clinical mental~~  
9 health counseling experience, including a minimum of 2,500 hours of  
10 direct client contact as determined by the Board.
- 11 (3) Has completed minimum education requirements in clinical supervision as  
12 approved by the Board.
- 13 (4) Has an active license in good standing as a licensed ~~professional-clinical~~  
14 mental health counselor approved by the Board.

15 **"§ 90-337. Persons credentialed in other states.**

16 (a) The Board may license any person who is currently licensed, certified, or registered  
17 by another state if the individual has met requirements determined by the Board to be  
18 substantially similar to or exceeding those established under this Article.

19 (b) The Board may enter into reciprocity agreements with another state that has  
20 requirements for licensure as a clinical mental health counselor that are substantially similar or  
21 that exceed requirements established under this Article.

22 **~~"§ 90-338. Exemptions.~~**

23 ~~Applicants holding certificates of registration as Registered Practicing Counselors and in~~  
24 ~~good standing with the Board shall be issued licenses as licensed professional counselors without~~  
25 ~~meeting the requirements of G.S. 90-336(e). The following applicants shall be exempt from the~~  
26 ~~academic qualifications required by this Article for licensed professional counselor associates or~~  
27 ~~licensed professional counselors and shall be licensed upon passing the Board examination and~~  
28 ~~meeting the experience requirements:~~

- 29 (1) ~~An applicant who was engaged in the practice of counseling before July 1,~~  
30 ~~1993, and who applied to the Board prior to January 1, 1996.~~
- 31 (2) ~~An applicant who holds a masters degree from a college or university~~  
32 ~~accredited by one of the regional accrediting associations or from a college or~~  
33 ~~university determined by the Board to have standards substantially equivalent~~  
34 ~~to a regionally accredited institution, provided the applicant was enrolled in~~  
35 ~~the masters program prior to July 1, 1994.~~

36 ...

37 **"§ 90-340. Protection of the public.**

38 (a) The Board may, in accordance with the provisions of Chapter 150B of the General  
39 Statutes, deny, suspend, or revoke licensure, discipline, place on probation, limit practice, or  
40 require examination, remediation, or rehabilitation of any person licensed under this Article on  
41 one or more of the following grounds:

- 42 (1) Has been convicted of a felony or entered a plea of guilty or nolo contendere  
43 to any felony charge under the laws of the United States or of any state of the  
44 United States.
- 45 (2) Has been convicted of or entered a plea of guilty or nolo contendere to any  
46 misdemeanor involving moral turpitude, misrepresentation, or fraud in  
47 dealing with the public, or conduct otherwise relevant to fitness to practice  
48 professional-clinical mental health counseling, or a misdemeanor charge  
49 reflecting the inability to practice professional-clinical mental health  
50 counseling with due regard to the health and safety of clients or patients.

- 1 (3) Has engaged in fraud or deceit in securing or attempting to secure or renew a  
2 license under this Article or has willfully concealed from the Board material  
3 information in connection with application for a license or renewal of a license  
4 under this Article.
- 5 (4) Has practiced any fraud, deceit, or misrepresentation upon the public, the  
6 Board, or any individual in connection with the practice of ~~professional~~  
7 clinical mental health counseling, the offer of ~~professional-clinical mental~~  
8 health counseling services, the filing of Medicare, Medicaid, or other claims  
9 to any third-party payor, or in any manner otherwise relevant to fitness for the  
10 practice of ~~professional-clinical mental health~~ counseling.
- 11 (5) Has made fraudulent, misleading, or intentionally or materially false  
12 statements pertaining to education, licensure, license renewal, certification as  
13 a health services provider, supervision, continuing education, any disciplinary  
14 actions or sanctions pending or occurring in any other jurisdiction,  
15 professional credentials, or qualifications or fitness for the practice of  
16 ~~professional-clinical mental health~~ counseling to the public, any individual,  
17 the Board, or any other organization.
- 18 (6) Has had a license or certification for the practice of ~~professional-clinical~~  
19 mental health counseling in any other jurisdiction suspended or revoked, or  
20 has been disciplined by the licensing or certification board in any other  
21 jurisdiction for conduct which would subject him or her to discipline under  
22 this Article.
- 23 (7) Has violated any provision of this Article or any rules adopted by the Board.
- 24 (8) Has aided or abetted the unlawful practice of ~~professional-clinical mental~~  
25 health counseling by any person not licensed by the Board.
- 26 (9) Has been guilty of immoral, dishonorable, unprofessional, or unethical  
27 conduct as defined in this subsection or in the current code of ethics of the  
28 American Counseling Association. However, if any provision of the code of  
29 ethics is inconsistent and in conflict with the provisions of this Article, the  
30 provisions of this Article shall control.
- 31 (10) Has practiced ~~professional-clinical mental health~~ counseling in such a manner  
32 as to endanger the welfare of clients.
- 33 (11) Has demonstrated an inability to practice ~~professional-clinical mental health~~  
34 counseling with reasonable skill and safety by reason of illness, inebriation,  
35 misuse of drugs, narcotics, alcohol, chemicals, or any other substance  
36 affecting mental or physical functioning, or as a result of any mental or  
37 physical condition.
- 38 (12) Has practiced ~~professional-clinical mental health~~ counseling outside the  
39 boundaries of demonstrated competence or the limitations of education,  
40 training, or supervised experience.
- 41 (13) Has exercised undue influence in such a manner as to exploit the client,  
42 patient, student, supervisee, or trainee for the financial or other personal  
43 advantage or gratification of the licensed ~~professional-clinical mental health~~  
44 counselor associate, licensed ~~professional-clinical mental health~~ counselor, or  
45 a third party.
- 46 (14) Has harassed or abused, sexually or otherwise, a client, patient, student,  
47 supervisee, or trainee.
- 48 (15) Has failed to cooperate with or to respond promptly, completely, and honestly  
49 to the Board, to credentials committees, or to ethics committees of  
50 professional associations, hospitals, or other health care organizations or  
51 educational institutions, when those organizations or entities have jurisdiction.

- 1 (16) Has refused to appear before the Board after having been ordered to do so in  
2 writing by the chair.
- 3 (17) Has a finding listed on the Division of Health Service Regulation of the  
4 Department of Health and Human Services Health Care Personnel Registry.
- 5 (b) The Board may, in lieu of denial, suspension, or revocation, take any of the following  
6 disciplinary actions:
- 7 (1) Issue a formal reprimand or formally censure the applicant or licensee.
- 8 (2) Place the applicant or licensee on probation with the appropriate conditions  
9 on the continued practice of ~~professional~~clinical mental health counseling  
10 deemed advisable by the Board.
- 11 (3) Require examination, remediation, or rehabilitation for the applicant or  
12 licensee, including care, counseling, or treatment by a professional or  
13 professionals designated or approved by the Board, the expense to be borne  
14 by the applicant or licensee.
- 15 (4) Require supervision of the ~~professional~~clinical mental health counseling  
16 services provided by the applicant or licensee by a licensee designated or  
17 approved by the Board, the expense to be borne by the applicant or licensee.
- 18 (5) Limit or circumscribe the practice of ~~professional~~clinical mental health  
19 counseling provided by the applicant or licensee with respect to the extent,  
20 nature, or location of the ~~professional~~clinical mental health counseling  
21 services provided, as deemed advisable by the Board.
- 22 (6) Discipline and impose any appropriate combination of the types of  
23 disciplinary action listed in this section.

24 In addition, the Board may impose conditions of probation or restrictions on continued  
25 practice of ~~professional~~clinical mental health counseling at the conclusion of a period of  
26 suspension or as a requirement for the restoration of a revoked or suspended license. In lieu of or  
27 in connection with any disciplinary proceedings or investigation, the Board may enter into a  
28 consent order relative to discipline, supervision, probation, remediation, rehabilitation, or  
29 practice limitation of a licensee or applicant for a license.

30 (c) The Board may assess costs of disciplinary action against an applicant or licensee  
31 found to be in violation of this Article.

32 (d) When considering the issue of whether an applicant or licensee is physically or  
33 mentally capable of practicing ~~professional~~clinical mental health counseling with reasonable  
34 skill and safety with patients or clients, upon a showing of probable cause to the Board that the  
35 applicant or licensee is not capable of practicing ~~professional~~clinical mental health counseling  
36 with reasonable skill and safety with patients or clients, the Board may petition a court of  
37 competent jurisdiction to order the applicant or licensee in question to submit to a psychological  
38 evaluation by a psychologist to determine psychological status or a physical evaluation by a  
39 physician to determine physical condition, or both. The psychologist or physician shall be  
40 designated by the court. The expenses of the evaluations shall be borne by the Board. Where the  
41 applicant or licensee raises the issue of mental or physical competence or appeals a decision  
42 regarding mental or physical competence, the applicant or licensee shall be permitted to obtain  
43 an evaluation at the applicant or licensee's expense. If the Board suspects the objectivity or  
44 adequacy of the evaluation, the Board may compel an evaluation by its designated practitioners  
45 at its own expense.

46 ...

47 **"§ 90-343. Disclosure.**

48 Any individual, or employer of an individual, who is licensed under this Article may not  
49 charge a client or receive remuneration for ~~professional~~clinical mental health counseling services  
50 unless, prior to the performance of those services, the client is furnished a copy of a Professional

1 Disclosure Statement that includes the licensee's professional credentials, the services offered,  
2 the fee schedule, and other provisions required by the Board.

3 ...  
4 **"§ 90-345. Criminal history record checks of applicants for licensure as ~~professional~~  
5 clinical mental health counselors.**

6 (a) Definitions. – The following definitions shall apply in this section:

7 (1) Applicant. – A person applying for licensure as a licensed ~~professional~~clinical  
8 mental health counselor associate pursuant to G.S. 90-336(b), 90-336(b1), or  
9 90-336(b2) or licensed ~~professional~~clinical mental health counselor pursuant  
10 to G.S. 90-336(c).

11 (2) Criminal history. – A history of conviction of a State or federal crime, whether  
12 a misdemeanor or felony, that bears on an applicant's fitness for licensure to  
13 practice ~~professional~~clinical mental health counseling. The crimes include the  
14 criminal offenses set forth in any of the following Articles of Chapter 14 of  
15 the General Statutes: Article 5, Counterfeiting and Issuing Monetary  
16 Substitutes; Article 5A, Endangering Executive and Legislative Officers;  
17 Article 6, Homicide; Article 7B, Rape and Other Sex Offenses; Article 8,  
18 Assaults; Article 10, Kidnapping and Abduction; Article 13, Malicious Injury  
19 or Damage by Use of Explosive or Incendiary Device or Material; Article 14,  
20 Burglary and Other Housebreakings; Article 15, Arson and Other Burnings;  
21 Article 16, Larceny; Article 17, Robbery; Article 18, Embezzlement; Article  
22 19, False Pretenses and Cheats; Article 19A, Obtaining Property or Services  
23 by False or Fraudulent Use of Credit Device or Other Means; Article 19B,  
24 Financial Transaction Card Crime Act; Article 20, Frauds; Article 21,  
25 Forgery; Article 26, Offenses Against Public Morality and Decency; Article  
26 26A, Adult Establishments; Article 27, Prostitution; Article 28, Perjury;  
27 Article 29, Bribery; Article 31, Misconduct in Public Office; Article 35,  
28 Offenses Against the Public Peace; Article 36A, Riots, Civil Disorders, and  
29 Emergencies; Article 39, Protection of Minors; Article 40, Protection of the  
30 Family; Article 59, Public Intoxication; and Article 60, Computer-Related  
31 Crime. The crimes also include possession or sale of drugs in violation of the  
32 North Carolina Controlled Substances Act in Article 5 of Chapter 90 of the  
33 General Statutes and alcohol-related offenses including sale to underage  
34 persons in violation of G.S. 18B-302 or driving while impaired in violation of  
35 G.S. 20-138.1 through G.S. 20-138.5. In addition to the North Carolina crimes  
36 listed in this subdivision, such crimes also include similar crimes under federal  
37 law or under the laws of other states.

38 ...."

39 **SECTION 1.(b)** This section is effective January 1, 2020.

41 **PART II. TECHNICAL AND CONFORMING CHANGES RELATED TO THE**  
42 **RENAMING OF THE LICENSED CLINICAL MENTAL HEALTH COUNSELORS**  
43 **ACT**

44 **SECTION 2.(a)** G.S. 8-53.8 read as rewritten:

45 **"§ 8-53.8. Counselor privilege.**

46 No person, duly licensed pursuant to Chapter 90, Article 24, of the General Statutes, shall be  
47 required to disclose any information which he or she may have acquired in rendering ~~professional~~  
48 clinical mental health counseling services, and which information was necessary to enable him  
49 or her to render ~~professional~~clinical mental health counseling services: Provided, that the  
50 presiding judge of a superior or district court may compel such disclosure, if in the court's opinion

1 the same is necessary to a proper administration of justice and such disclosure is not prohibited  
2 by other statute or regulation."

3 **SECTION 2.(b)** G.S. 48-10-103(a)(3) reads as rewritten:

4 "(3) Counseling services for a parent or the adoptee that are directly related to the  
5 adoption and are provided by a licensed psychiatrist, licensed psychologist,  
6 licensed marriage and family therapist, licensed ~~professional~~clinical mental  
7 health counselor, licensed or certified social worker, fee-based practicing  
8 pastoral counselor or other licensed ~~professional~~clinical mental health  
9 counselor, or an employee of an agency;"

10 **SECTION 2.(c)** G.S. 55B-2(6) reads as rewritten:

11 "(6) The term "professional service" means any type of personal or professional  
12 service of the public which requires as a condition precedent to the rendering  
13 of such service the obtaining of a license from a licensing board as herein  
14 defined, and pursuant to the following provisions of the General Statutes:  
15 Chapter 83A, "Architects"; Chapter 84, "Attorneys-at-Law"; Chapter 93,  
16 "Public Accountants"; and the following Articles in Chapter 90: Article 1,  
17 "Practice of Medicine," Article 2, "Dentistry," Article 6, "Optometry," Article  
18 7, "Osteopathy," Article 8, "Chiropractic," Article 9A, "Nursing Practice Act,"  
19 with regard to registered nurses, Article 11, "Veterinarians," Article 12A,  
20 "Podiatrists," Article 18A, "Practicing Psychologists," Article 18C, "Marriage  
21 and Family Therapy Licensure," Article 18D, "Occupational Therapy,"  
22 Article 22, "Licensure Act for Speech and Language Pathologists and  
23 Audiologists," and Article 24, "Licensed ~~Professional-Clinical Mental Health~~  
24 Counselors"; Chapter 89C, "Engineering and Land Surveying"; Chapter 89A,  
25 "Landscape Architects"; Chapter 90B, "Social Worker Certification and  
26 Licensure Act" with regard to Licensed Clinical Social Workers as defined by  
27 G.S. 90B-3; Chapter 89E, "Geologists"; Chapter 89B, "Foresters"; and  
28 Chapter 89F, "North Carolina Soil Scientist Licensing Act"."

29 **SECTION 2.(d)** G.S. 55B-14(c)(4) reads as rewritten:

30 "(4) A physician, a licensed psychologist, a licensed clinical social worker, or each  
31 of them and a certified clinical specialist in psychiatric and mental health  
32 nursing, a licensed marriage and family therapist, a licensed ~~professional~~

50 of the following professionals, so long as the services or supervision



provided is commensurate with the professional's training, experience, and scope of practice:

1. A licensed psychologist or psychological associate.
2. A licensed psychiatrist or developmental pediatrician.
3. A licensed speech and language pathologist.
4. A licensed occupational therapist.
5. A licensed clinical social worker.
6. A licensed ~~professional~~-clinical mental health counselor.
7. A licensed marriage and family therapist.
8. A board certified behavior analyst.

...

- (8) Therapeutic care. – Direct or consultative services provided by a licensed speech therapist, licensed occupational therapist, licensed physical therapist, licensed clinical social worker, licensed ~~professional~~-clinical mental health counselor, or licensed marriage and family therapists.

...."

**SECTION 2.(f)** G.S. 58-50-30(b)(12) reads as rewritten:

"(12) A ~~professional~~-clinical mental health counselor licensed by the North Carolina Board of Licensed ~~Professional-Clinical Mental Health~~ Counselors pursuant to Article 24 of Chapter 90 of the General Statutes."

**SECTION 2.(g)** G.S. 90-21.41(2) reads as rewritten:

"(2) Psychotherapist. – A psychiatrist licensed in accordance with Article 1 of Chapter 90 of the General Statutes, a psychologist as defined in G.S. 90-270.2(9), a licensed ~~professional~~-clinical mental health counselor as defined in ~~G.S. 90-330(a)(2)~~, G.S. 90-330(a), a substance abuse professional as defined in G.S. 90-113.31(8), a social worker engaged in a clinical social work practice as defined in G.S. 90B-3(6), a fee-based pastoral counselor as defined in G.S. 90-382(4), a licensed marriage and family therapist as defined in G.S. 90-270.47(3), or a mental health service provider, who performs or purports to perform psychotherapy."

However, in no event may a person use the title "Licensed Marriage and Family Therapist" or "Licensed Marriage and Family Therapy Associate," use the letters "LMFT" or "LMFTA," or in any way imply that the person is a licensed marriage and family therapist or a licensed marriage and family therapy associate unless the person is licensed as such under this Article."

13 upon completion of a refresher training program approved by the Department.

14 (5) In no event shall the certification of a licensed clinical social worker, master's

15 or higher level degree nurse practitioner, licensed ~~professional-clinical mental~~

16 health counsellor, physician assistant, or master's level certified clinical

17 addictions specialist under this section be construed as authorization to expand

18 the scope of practice of the licensed clinical social worker, the master's level

19 nurse practitioner, licensed ~~professional-clinical mental health~~ counsellor,

19 credentialed pursuant to this Article for the purposes of identifying, reviewing, and evaluating  
20 the ability of substance use disorder professionals who are referred or self-referred to the Program  
21 to (i) function in their professional capacity and (ii) coordinate regimens for treatment and  
22 rehabilitation.

23 (c) An agreement entered into between the Program and a credentialed professional  
24 pursuant to subdivision (b) of this section shall include guidelines for all of the following:

- 25 (1) Enrollment of credentialed professionals referred to the Program by the Board.
- 26 (2) Assessment, referral, monitoring, support, and education of credentialed  
27 professionals referred to the Program by reason of a physical or mental illness,  
28 a substance use disorder, or professional sexual misconduct.
- 29 (3) Consistent with subsection (d) of this section, criteria for the Program to report  
30 credentialed professionals to the Board.
- 31 (4) Procedures by which credentialed professionals may obtain review of  
32 Program recommendations about the credentialed professional regarding  
33 assessment or treatment.
- 34 (5) Periodic reporting of statistical information by the Program to the Board.
- 35 (6) Maintaining the confidentiality of nonpublic information.

36 (d) The Program shall report immediately to the Board detailed information about any  
37 professional credentialed pursuant to this Article who meets any of the following criteria:

- 38 (1) Constitutes an imminent danger to patient care by reason of mental illness,  
39 physical illness, substance use disorder, professional sexual misconduct, or  
40 any other reason.
- 41 (2) Refuses to submit to an assessment as ordered by the Program.
- 42 (3) Has entered into a monitoring contract as a Program participant and fails to  
43 comply with the terms of the monitoring contract.
- 44 (4) Is still unsafe to practice as a substance use disorder professional after  
45 completing Program services.

46 (e) All documents, papers, letters, recordings, electronic records, or other documentary  
47 materials in the possession of the Program or its staff, employees, legal counsel, and volunteers,  
48 relating in any way to a member's participation or prospective participation in the Program,  
49 including, but not limited to, any medical, counseling, substance abuse, or mental health records,  
50 shall not be considered public records within the meaning of Chapter 132 of the General Statutes.  
51 No person participating in good faith in the Program shall be required in a civil action or

1 proceeding to disclose the fact of participation in the Program or disclose any information  
2 acquired or opinions, recommendations, or evaluations acquired or developed solely in the course  
3 of participating in the Program pursuant to this section. For purposes of this subsection, "civil  
4 action or proceeding" does not include an administrative action or proceeding conducted under  
5 this Article or under Chapter 150B of the General Statutes.

6 (f) Activities conducted in good faith pursuant to the agreement authorized by subsection  
7 (b) of this section shall not be grounds for civil action under the laws of this State.

8 (g) Upon the written request of a professional credentialed pursuant to this Article, the  
9 Program shall provide the credentialed professional and his or her legal counsel with a copy of a  
10 written assessment of the credentialed professional prepared as part of his or her participation in  
11 the Program. In addition, to the extent permitted by State and federal laws, the credentialed  
12 professional shall be entitled to a copy of any written assessment created by a treatment provider  
13 or facility at the recommendation of the Program. Any information the Program furnishes to a  
14 credentialed professional pursuant to this subsection shall be inadmissible in evidence and shall  
15 not be subject to discovery in any civil action or proceeding; provided, however, that this  
16 subsection shall not be construed to make information, documents, or records otherwise available  
17 for discovery or use in a civil action or proceeding immune from discovery or use in the civil  
18 action or proceeding merely because the information, documents, or records were included as  
19 part of the Program's assessment of the credentialed professional or were the subject of  
20 information furnished to the credentialed professional pursuant to this subsection. For purposes  
21 of this subsection, "civil action or proceeding" does not include an administrative action or  
22 proceeding conducted under this Article or Chapter 150B of the General Statutes.

23 (h) The Board shall adopt rules to apply to the operation of the Program, with provisions  
24 for at least all of the following:

25 (1) Definitions of impairments attributed to physical or mental illness, substance  
26 use disorder, and professional sexual misconduct.

27 (2) Guidelines for Program elements.

28 (3) Procedures for receipt and use of information of suspected impairment.

29 (4) Procedures for intervention and referral.

30 (5) Arrangements for monitoring treatment, rehabilitation, posttreatment support,  
31 and performance.

32 (6) Reports of individual cases to the Board.

33 (7) Periodic reporting of statistical information.

34 (8) Assurance of confidentiality of nonpublic information."

35 **SECTION 6.(b)** This section becomes effective October 1, 2019, and applies to  
36 licenses granted or renewed on or after that date.

1 education of credentialed substance ~~abuse-use~~ disorder professionals, and to ensure the

 25 ~~substance abuse alcohol and drug~~ counselor in accordance with the provisions  
 26 of this Article.
- 27 (7) Certified ~~substance abuse prevention consultant-specialist~~. – A person  
 28 certified by the Board to practice substance ~~abuse-use~~ disorder prevention in  
 29 accordance with the provisions of this Article.
- 30 ...
- 31 (14) Criminal history. – A history of conviction of a State crime, whether a  
 32 misdemeanor or felony, that bears on an applicant's fitness for licensure to  
 33 practice substance ~~abuse-use~~ disorder professional services. The crimes  
 34 include the criminal offenses set forth in any of the following Articles of  
 35 Chapter 14 of the General Statutes: Article 5, Counterfeiting and Issuing  
 36 Monetary Substitutes; Article 5A, Endangering Executive and Legislative  
 37 Officers; Article 6, Homicide; Article 7B, Rape and Other Sex Offenses;  
 38 Article 8, Assaults; Article 10, Kidnapping and Abduction; Article 13,  
 39 Malicious Injury or Damage by Use of Explosive or Incendiary Device or  
 40 Material; Article 14, Burglary and Other Housebreakings; Article 15, Arson  
 41 and Other Burnings; Article 16, Larceny; Article 17, Robbery; Article 18,  
 42 Embezzlement; Article 19, False Pretenses and Cheats; Article 19A,  
 43 Obtaining Property or Services by False or Fraudulent Use of Credit Device  
 44 or Other Means; Article 19B, Financial Transaction Card Crime Act; Article  
 45 20, Frauds; Article 21, Forgery; Article 26, Offenses Against Public Morality  
 46 and Decency; Article 26A, Adult Establishments; Article 27, Prostitution;  
 47 Article 28, Perjury; Article 29, Bribery; Article 31, Misconduct in Public  
 48 Office; Article 35, Offenses Against the Public Peace; Article 36A, Riots,  
 49 Civil Disorders, and Emergencies; Article 39, Protection of Minors; Article

 51 Computer-Related Crime. The crimes also include possession or sale of drugs

 32 clinical supervisor, licensed clinical addictions specialist associate, licensed

 34 director, clinical supervisor intern, or certified criminal justice addictions  
 35 professional."

  - (2a) The use of drugs or alcoholic beverages to the extent that a substance ~~abuse~~ use disorder professional suffers impairment.
  - (3) Conviction of an offense under any municipal, State, or federal law other than traffic laws as prescribed by Chapter 20 of the General Statutes.
  - (4) Conviction of a felony or other public offense involving moral turpitude. Conviction of a Class A-E felony shall result in an immediate suspension of licensure, certification, or registration for a minimum of one year.
  - (5) An adjudication of insanity or incompetency, until proof of recovery from this condition can be established by a licensed psychologist or psychiatrist.
  - (6) Engaging in any act or practice in violation of any of the provisions of this Article or any of the rules adopted pursuant to it, or aiding, abetting, or assisting any other person in such a violation.
  - (7) The commission of an act of malpractice, gross negligence, or incompetence while serving as a substance ~~abuse-use disorder~~ professional, intern, or registrant.
  - (8) Repealed by Session Laws 2005-431, s. 1, effective September 22, 2005.
  - (9) Engaging in conduct that could result in harm or injury to the public.
  - (10) Entering into a dual relationship that impairs professional judgment or increases the risk of exploitation with a client or supervisee.
  - (11) Practicing as a credentialed substance ~~abuse-use disorder~~ professional outside of his or her scope of practice pursuant to G.S. 90-113.31B.

(b) Denial of an applicant's licensure, certification, or registration or the granting of licensure, certification, or registration on a probationary or other conditional status shall be subject to substantially the same rules and procedures prescribed by the Board for review and disciplinary actions against any person holding a license, certificate, or registration. A suspension of a credential resulting from impairment due to substance use, mental health, or medical disorder shall be imposed for at least six months beginning from the date of successful discharge from a residential substance ~~abuse-use disorder~~ treatment program or other appropriate treatment modality determined as a result of an assessment by a Board-approved assessor. Disciplinary actions involving a clinical addictions specialist whose licensure is achieved through deemed status shall be initially heard by the specialist's credentialing body. The specialist may appeal the

1 body's decision to the Board. The Board shall, however, have the discretionary authority to hear  
2 the initial disciplinary action involving a credentialed professional."

3 **SECTION 7.(o)** G.S. 90-113.46 reads as rewritten:

6 who resides and practices social work in this State while credentialed in another state or  
7 jurisdiction shall clearly amend reference to his or her credential identifying the state or

21 officer of the legislative, executive or judicial branches of State government or counties, cities,

This includes persons in such positions in counties whose classification and compensation systems have been certified as substantially equivalent by the State Human Resources Commission and persons serving in such positions in Human Services agencies created by counties pursuant to G.S. 153A-77.

**"§ 90B-11. Disciplinary procedures.**

(a) The Board may, in accordance with the provisions of Chapter 150B of the General Statutes, deny, suspend, or revoke an application, certificate, or license on any of the following grounds:

- (1) Conviction of ~~a misdemeanor~~ or the entering of a plea of guilty or nolo contendere to ~~a any misdemeanor under this Chapter involving moral turpitude, misrepresentation or fraud in dealing with the public, conduct otherwise relevant to fitness to practice social work, or any misdemeanor reflecting inability to practice social work with due regard to the health and safety of clients or patients.~~
- (2) Conviction of a felony or the entering of a plea of guilty or nolo contendere to a felony under the laws of the United States or of any state of the United States.
- (3) Gross unprofessional conduct, dishonest practice or incompetence in the practice of social work.
- (4) Procuring or attempting to procure a certificate or license by fraud, deceit, or misrepresentation.
- (5) Any fraudulent or dishonest conduct in social work.
- (6) Inability of the person to perform the functions for which he or she is certified or licensed, or substantial impairment of abilities by reason of physical or mental disability.
- (7) Violations of any of the provisions of this Chapter or of rules of the Board.

(d) In considering whether an applicant, certificate holder, or licensee is mentally or physically capable of practicing social work with reasonable skill and safety, the Board may require an applicant, certificate holder, or licensee to submit to any of the following, at his or her own expense: (i) a criminal history record check, including fingerprints, (ii) a mental examination and substance abuse assessment by a licensed clinical social worker or other licensed mental health professional designated by the ~~Board~~ Board, and ~~to (iii) a physical examination~~ by a physician or other licensed health professional designated by the Board. The examination may be ordered by the Board before or after charges are presented against the applicant, certificate holder, or licensee and the results of the examination shall be reported directly to the Board and shall be admissible in evidence in a hearing before the Board.

...

(h) The Board may assess costs of disciplinary action against an applicant, certificate holder, or licensee found to be in violation of the provisions of this Chapter or of any rules adopted by the Board pursuant to this Chapter."

**SECTION 9.(b)** This section becomes effective January 1, 2021. Qualifications for the certificate of Certified Social Work Manager, as amended by this act, apply only to applications for certification received by the Board on or after January 1, 2021.
