1 moves to amend the bill on page 147, lines 11-12,  
2 by inserting the following new section between those lines to read:

4 **"REPURPOSE FUNDS FROM CAROLINA PREGNANCY CARE FELLOWSHIP AND**  
5 **HUMAN COALITION TO INCREASE SMART START FUNDS**

6 **SECTION 9C.7.** Notwithstanding any other provision of this act, recurring funds  
7 appropriated in this act to the Department of Health and Human Services, Division of Public  
8 Health, for the Carolina Pregnancy Care Fellowship (13A1) for each year of the 2019-2021 fiscal  
9 biennium in the amount of four hundred thousand dollars (\$400,000) and nonrecurring funds  
10 appropriated in this act to the Division of Public Health for the Human Coalition (13A1) for each  
11 year of the 2019-2021 fiscal biennium in the amount of one million two hundred thousand dollars  
12 (\$1,200,000) shall not be used for those purposes, but instead shall be used to increase the funds  
13 appropriated in this act to the Department of Health and Human Services, Division of Child  
14 Development and Early Education, for each year of the 2019-2021 fiscal biennium for Smart  
15 Start Funds increased for Smart Start pursuant to this section shall be allocated as follows:

- 16 (1) Funds for Smart Start Child Care Related Activities (1162) shall be increased  
17 by the sum of two hundred eighty thousand dollars (\$280,000) recurring and  
18 eight hundred forty thousand dollars (\$840,000) nonrecurring for each year of  
19 the 2019-2021 fiscal biennium.  
20 (2) Funds for Smart Start Family Support Services (1271) shall be increased by  
21 the sum of one hundred twenty thousand dollars (\$120,000) recurring and  
22 three hundred sixty thousand dollars (\$360,000) nonrecurring for each year of  
23 the 2019-2021 fiscal biennium."; and

25 on page 174, lines 20-25, by deleting those lines; and

27 on page 174, lines 40-51 through page 175, lines 1-46, by deleting those lines; and
