Representative R. Smith

moves to amend the bill on page 2, line 7, by increasing the requirements for the 2019-2020 fiscal year by \$2,000,000 and increasing the requirements for the 2020-2021 fiscal year by \$2,000,000; and

on page 2, line 22, by decreasing the requirements for the 2019-2020 fiscal year by \$1,200,000 and decreasing the requirements for the 2020-2021 fiscal year by \$1,200,000; and

on page 2, line 27, by decreasing the requirements for the 2019-2020 fiscal year by \$800,000 and decreasing the requirements for the 2020-2021 fiscal year by \$800,000; and

on page 100, lines 23-24, by inserting between those lines the following new section to read:

"NC A&T STATE UNIVERSITY AG AND COOPERATIVE EXTENSION FUNDS

SECTION 8.12.(a) Notwithstanding any other provision law, the funds appropriated by this act to the Board of Governors of The University of North Carolina for the 2019-2021 fiscal biennium for North Carolina Agricultural and Technical State University (NC A&T State University) in Fund Code 16070 shall be increased by two million dollars (\$2,000,000) in recurring funds for the 2019-2020 fiscal year to support NC A&T State University's agricultural research and cooperative extension activities by matching federal funds awarded to NC A&T State University as a land-grant university pursuant to the National Agricultural Research, Extension, and Teaching Policy Act of 1977, as amended, 7 U.S.C. § 3221, et seq. The required minimum match for eligibility under the program is one dollar (\$1.00) in nonfederal funds, including those made available by State appropriation, for every one dollar (\$1.00) in federal funds for agricultural research and extension activities approved in the plan of work submitted to the Secretary of Agriculture of the United States.

SECTION 8.12.(b) Notwithstanding any other provision law, the funds appropriated by this act to the Board of Governors of The University of North Carolina for the 2019-2021 fiscal biennium for North Carolina State University for agricultural research in Fund Code 16031 shall be reduced by one million two hundred thousand dollars (\$1,200,000) in recurring funds for the 2019-2020 fiscal year.
