5	The General Assembly of North Carolina enacts:	
6	SECTION 1. There is established the Joint Study Committee on Parity for First	
7	Responders (Committee). The Committee shall consist of five members of the House of	
8	Representatives, appointed by the Speaker of the House of Representatives, with one member	
9	designated as cochair, and five members of the Senate, appointed by the President Pro Tempor	re
10	of the Senate, with one member designated as cochair. Members serve at the pleasure of th	ıe
11	appointing officer.	
12	SECTION 2. The Committee shall study a special separation allowance for Stat	te
13	and local firefighters and rescue squad workers. At a minimum, the Committee shall do th	ıe
14	following:	
15	(1) Work with the municipalities and the State Treasurer to determine the cost t	
16	each municipality for the cities and counties to provide a separation allowanc	
17	to local firefighters and rescue squad workers with a plan implementation dat	te
18	of July 1, 2024.	
19	(2) Determine funds availability and current funding sources that could be use	ed
20	by the municipalities to provide a separation allowance.	
21	(3) Develop a funding mechanism to pay for a separation allowance on a	ın
22	actuarially sound basis.	
23	(4) Consider alternative benefit designs that would yield a benefit equivalent to	a
24	separation allowance, if applicable.	
25	(5) Explore other issues the Committee identifies that are related to the objective	es
26	of this study.	
27	SECTION 3. The Committee shall meet upon the call of its cochairs. A quorum of	
28	the Committee is a majority of its members. No action may be taken except by a majority vot	
29	at a meeting at which a quorum is present. Members of the Committee shall receive subsistence	e
30	and travel expenses as provided in G.S. 120-3.1.	
31	SECTION 4. The Committee, while in the discharge of its official duties, ma	-
32	exercise all powers provided for under G.S. 120-19 and Article 5A of Chapter 120 of the Genera	
33	Statutes. The Committee may contract for professional, clerical, or consultant services, a	1S
34	provided by G.S. 120-32.02.	
35	SECTION 5. The Legislative Services Officer shall assign professional and clerica	
36	staff to assist the Committee in its work. The Director of Legislative Assistants of the House of	of

1 Representatives and the Director of Legislative Assistants of the Senate shall assign clerical 2 support staff to the Committee. 3 SECTION 6. The Committee may solicit input from relevant State departments, 4 municipalities, State and municipal organizations, and other stakeholders while conducting the 5 study. 6 **SECTION 7.** The Committee shall submit a final report on the results of its study, 7 including proposed legislation, to the members of the Senate and the House of Representatives 8 on or before the convening of the 2020 Regular Session of the 2019 General Assembly, by filing 9 a copy of the report with the Office of the President Pro Tempore of the Senate, the Office of the 10 Speaker of the House of Representatives, and the Legislative Library. The Committee shall

11 terminate on May 15, 2020, or upon the filing of its final report, whichever occurs first.

12 **SECTION 8.** This act is effective when it becomes law.
