2	AN ACT REMOVING CERTAIN DESCRIBED PROPERTY FROM THE CORPORATE
3	LIMITS OF THE CITY OF DURHAM AND REMOVING CERTAIN DESCRIBED
4	PROPERTY FROM THE CORPORATE LIMITS OF THE VILLAGE OF CLEMMONS.
5	The General Assembly of North Carolina enacts:
6	SECTION 1.(a) The following described property is removed from the corporate
7	limits of the City of Durham:
8	Being all the lands described in Deed Book 1251, Page 422, to BEMAC Partners,
9	Deed Book 1014, Page 817, and Deed Book 300, Page 237, to Lillie Eve Umstead, being further
10	described as follows: BEGINNING at an existing iron pin, said point being the southwest corner

Such liens may be collected or foreclosed upon after the effective date of this act 20 as though the property were still within the corporate limits of the Village of Clemmons.

21 **SECTION 3.** This act becomes effective June 30, 2020. Property in the territory 22 described in Section 1 and Section 2 of this act as of January 1, 2020, is no longer subject to 23 municipal taxes for taxes imposed for taxable years beginning on or after July 1, 2020.
