1	(d) Application of Proceeds. – Except as otherwise provided in this section, net proceeds
2	shall be handled in accordance with the provisions of G.S. 146-30.
3	(e) Exception. – This section shall not apply to proceeds derived from the sale of land or
4	property originally purchased with, under the supervision and control of, or maintained with
5	funds from the State Highway Fund or proceeds derived from the disposition of residue property
6	pursuant to G.S. 136-19.7."
7	SECTION 2. G.S. 20-28.9 reads as rewritten:
8	"§ 20-28.9. Authority for the State Surplus Property Agency to administer a statewide or
9	regional towing, storage, and sales program for vehicles forfeited.
10	(a) The State Surplus Property Agency is authorized to <u>and shall</u> enter into a contract for
11	a statewide service or two contracts for regional services to tow, store, process, maintain, and sell
12	motor vehicles seized pursuant to G.S. 20-28.3. All motor vehicles seized under G.S. 20-28.3
13	shall be subject to contracts entered into pursuant to this section. Contracts shall be let by the
14	State Surplus Property Agency in accordance with the provisions of Article 3 of Chapter 143 of
15	the General Statutes. The State Surplus Property Agency must select one separate vendor for
16	each of the contracts let pursuant to this subsection. All contracts shall ensure the safety of the
17	motor vehicles while held and any funds arising from the sale of any seized motor vehicle. The
18	contract shall require the contractor to maintain and make available to the agency a computerized
19	up-to-date inventory of all motor vehicles held under the contract, together with an accounting
20	of all accrued charges, the status of the vehicle, and the county school fund to which the proceeds
21	of sale are to be paid. The contract shall provide that the contractor shall pay the towing and
22	storage charges owed on a seized vehicle to a commercial towing company at the time the seized
23	vehicle is obtained from the commercial towing company, with the contractor being reimbursed
24	this expense when the vehicle is released or sold. The State Surplus Property Agency shall not
25	enter into any contract under this section under which the State will be obligated to pay a
26	deficiency arising from the sale of any forfeited motor vehicle.

28	SECTION 3. G.S. 20-28.3(i) reads as rewritten:

29 "(i) Expedited Sale of Seized Motor Vehicles in Certain Cases. - In order to avoid 30 additional liability for towing and storage costs pending resolution of the criminal proceedings of the defendant, the State Surplus Property Agency or county board of education may, after 31 32 expiration of 90 days from the date of seizure, sell any motor vehicle having a fair market value 33 of one thousand five hundred dollars (\$1,500) or less. The State Surplus Property Agency or 34 county board of education may also sell a motor vehicle, regardless of the fair market value, any 35 time the outstanding towing and storage costs exceed eighty-five percent (85%) of the fair market 36 value of the vehicle, or with the consent of all the motor vehicle owners. Any sale conducted 37 pursuant to this subsection shall be conducted in accordance with the provisions of 38 G.S. 20-28.5(a) or G.S. 20-28.5(a1), as applicable, and the proceeds of the sale, after the payment 39 of outstanding towing and storage costs or reimbursement of towing and storage costs paid by a 40 person other than the defendant, shall be deposited with the clerk of superior court. If an order of forfeiture is entered by the court, the court shall order the proceeds held by the clerk to be 41 42 disbursed as provided in G.S. 20-28.5(b). If the court determines that the motor vehicle is not 43 subject to forfeiture, the court shall order the proceeds held by the clerk to be disbursed first to 44 pay the sale, towing, and storage costs, second to pay outstanding liens on the motor vehicle, and 45 the balance to be paid to the motor vehicle owners."

SECTION 4. This act becomes effective September 1, 2019.
