1	moves to amend the bill on page 1, lines $1 - 2$, by rewriting the lines to read:

5	CLARIFY JUDICIAL STANDARDS COMMISSION PROCEDURES.";

9	"PART IV. CLARIFY JUDICIAL STANDARDS COMMISSION INVESTIGATIONS
10	AGAINST JUDGES
11	SECTION 4.(a) G.S. 7A-377(a) reads as rewritten:
12	"(a) Any citizen of the State may file a written complaint with the Commission concerning
13	the qualifications or conduct of any justice or judge of the General Court of Justice, and thereupon
14	the Commission shall make such investigation as it deems necessary. The Commission may also
15	make an investigation on its own motion. The Commission shall not make an investigation,
16	whether initiated upon its own motion or by written complaint of a citizen of this State, when the
17	motion or complaint is based substantially upon a legal ruling by a district or superior court judge
18	and the legal ruling has not yet been reviewed and ruled upon by either the North Carolina Court
19	of Appeals or the North Carolina Supreme Court. The Commission is limited to reviewing
20	judicial conduct, not matters of law. The Commission may issue process to compel the attendance
21	of witnesses and the production of evidence, to administer oaths, and to punish for contempt. No
22	justice or judge shall be recommended for public reprimand, censure, suspension, or removal
23	unless he has been given a hearing affording due process of law."
24	SECTION 4.(b) This section is effective when it becomes law and applies to
25	complaints or investigations pending on or after that date.

27	PART V. SEVERABILITY CLAUSE

SECTION 5. If any provision of this act or its application is held invalid, the invalidity does not affect other provisions or applications of this act that can be given effect without the invalid provisions or application, and to this end, the provisions of this act are severable.
